1 purchases from persons, firms, or corporations regularly engaged in the business of manufacturing recyclable metal, 2 in the business of selling recyclable metal at retail or 3 4 wholesale, or in the business of razing, demolishing, 5 destroying, or removing buildings, to the purchase by one 6 recyclable metal dealer from another, or the purchase from persons, firms, or corporations engaged in either the 7 generation, transmission, or distribution of electric 8 9 energy or in telephone, telegraph, and other 10 communications if such common carriers, persons, firms, or corporations at the time of the purchase provide the 11 recyclable metal dealer with a bill of sale or other 12 written evidence of title to the recyclable metal. This 13 subdivision (a) (5) also does not apply to contractual 14 15 arrangements between dealers."; and
