Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 5. - 12 Section 30. The sum of \$0, minus the amount transferred
- 13 to the General Assembly Retirement System pursuant to

- 15 Fund Continuing Appropriation Act, is appropriated from the
- 16 State Pensions Fund to the Board of Trustees of the General
- 17 Assembly Retirement System, pursuant to the provisions of
- 18 Section 8.12 of "An Act in relation to State finance",
- 19 approved June 10, 1919, as amended.
- 20 Section 99. Effective Date. This Act takes effect July
- 21 1, 2008.
