Section 20. 1 Section 25. The following named amount, \$231,400, or so 2 much thereof as may be necessary, respectively, is 3 appropriated from the General Revenue Fund to the Office of 4 the State Appellate Defender for the ordinary and contingent 5 expenses of the Expungement Program.

6 Section 30. The sum of \$3,716, or so much thereof as may 7 be necessary, is appropriated from the General Revenue Fund 8 to the State Appellate Defender for deposit into the State 9 Appellate Defender Federal Trust Fund.

10 Section 35. The sum of \$3,716, or so much thereof as may 11 be necessary, is appropriated from the State Appellate 12 Defender Federal Trust Fund for a refund to the Illinois 13 Criminal Justice Information Authority.
