

## 95TH GENERAL ASSEMBLY State of Illinois 2007 and 2008 SB0034

Introduced 1/31/2007, by Sen. Todd Sieben

## SYNOPSIS AS INTRODUCED:

815 ILCS 305/15

from Ch. 134, par. 115

Amends the Automatic Telephone Dialers Act. Requires all autodialers operated within the State to immediately disconnect after termination of the call by the subscriber or the autodialer or, if immediate disconnection is not possible, to use a live operator. Requires an autodialer to provide the complete company name, address, and return phone number within its pre-recorded message. Provides that an autodialer shall provide within the pre-recorded message an option of pressing a designated button to connect with a live operator at any time during the message. Requires an autodialer to be properly registered so that the name and telephone number displays on any caller ID. Effective January 1, 2008.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Automatic Telephone Dialers Act is amended by changing Section 15 as follows:
- 6 (815 ILCS 305/15) (from Ch. 134, par. 115)
- 7 Sec. 15. Method of operation.
- 8 (a) No person shall operate an autodialer in this State to
- 9 place a telephone call during the hours between 9 p.m. and 9  $\,$
- 10 a.m.
- 11 (b) All autodialers operated within the State of Illinois
- 12 shall disconnect <u>immediately</u> within 30 seconds after
- termination of the call by the subscriber or the autodialer.
- 14 Where  $\underline{immediate}$  disconnection  $\underline{in}$  30  $\underline{seconds}$  is technically not
- 15 feasible, the autodialer shall utilize a live operator who
- 16 shall:
- 17 (1) state his name, the name, address and telephone
- 18 number of the business or organization being represented
- and the purpose of the call; and
- 20 (2) inquire at the beginning of the call whether the 21 person called consents to hear the prerecorded message.
- 22 (b-5) An autodialer shall provide the complete company
- 23 name, address, and return phone number within its pre-recorded

- 1 <u>message</u>.
- 2 (c) An autodialer shall not be used to dial numbers 3 determined by successively increasing or decreasing integers.
- (d) An autodialer must be properly registered so that the

  name and telephone number displays on any caller ID. An

  autodialer may not be operated in a manner that impedes the

  function of any caller ID when the telephone solicitor's

  service or equipment is capable of allowing the display of the

  solicitor's telephone number.
- 10 <u>(e) An autodialer shall provide within the pre-recorded</u>
  11 <u>message an option of pressing a designated button to connect</u>
  12 with a live operator at any time during the message.

- Section 99. Effective date. This Act takes effect January 1, 2008.
