Amend Senate Bill 194 as follows: 3 on page 13, line 4, after "2004.", by inserting the following: "For annexations that are eligible for payments under this 4 5 paragraph (6.5) and that are effective on or after July 1, 2004, but before the effective date of this amendatory Act of 6 7 the 95th General Assembly, the first required yearly payment under this paragraph (6.5) shall be paid in the fiscal year of 8 the effective date of this amendatory Act of the 95th General 9 Assembly. Subsequent required yearly payments shall be paid in 10 11 subsequent fiscal years until the payment obligation under this paragraph (6.5) is complete."; and 12 13 on page 19, line 4, after "2004.", by inserting the following: "For annexations that are eligible for payments under this 14 paragraph (5.10) and that are effective on or after July 1, 15 2004, but before the effective date of this amendatory Act of 16

- 1 the 95th General Assembly, the first required yearly payment
- 2 under this paragraph (5.10) shall be paid in the fiscal year of
- 3 the effective date of this amendatory Act of the 95th General
- 4 Assembly. Subsequent required yearly payments shall be paid in
- 5 subsequent fiscal years until the payment obligation under this
- 6 paragraph (5.10) is complete."; and
- on page 19, line 19, after "Code", by inserting the following:
- 8 ", except that for an annexation of territory detached from a
- 9 school district that is effective on or after July 1, 2004, but
- 10 before the effective date of this amendatory Act of the 95th
- 11 General Assembly, whereby the enrollment of the annexing
- 12 district increases by 90% or more as a result of the
- annexation, reimbursement shall begin during the fiscal year of
- 14 the effective date of this amendatory Act of the 95th General
- 15 Assembly"; and
- on page 27, line 16, after "2004.", by inserting the following:
- 17 "For annexations that are eligible for payments under this
- paragraph (6.5) and that are effective on or after July 1,
- 19 2004, but before the effective date of this amendatory Act of
- 20 the 95th General Assembly, the required payment under this
- 21 paragraph (6.5) shall be paid in the fiscal year of the
- 22 <u>effective date of this amendatory Act of the 95th General</u>
- 23 Assembly."; and

- on page 34, line 3, after "2004.", by inserting the following:
- 2 "For annexations that are eligible for payments under this
- 3 paragraph (2.10) and that are effective on or after July 1,
- 4 2004, but before the effective date of this amendatory Act of
- 5 the 95th General Assembly, the first required yearly payment
- 6 under this paragraph (2.10) shall be paid in the second fiscal
- 7 year after the effective date of this amendatory Act of the
- 8 95th General Assembly. Any subsequent required yearly payments
- 9 shall be paid in subsequent fiscal years until the payment
- obligation under this paragraph (2.10) is complete."; and
- on page 35, lines 4 and 5, by replacing "upon becoming law"
- 12 with "July 1, 2007".
