Amends the New Vehicle Buyer Protection Act. Includes vehicles purchased by a fire department, fire protection district, or township fire department in the definition of "vehicle" and includes a fire department, fire protection district, or township fire department in the definition of "consumer".

1 AN ACT concerning business.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The New Vehicle Buyer Protection Act is amended
by changing Section 2 as follows:

6 (815 ILCS 380/2) (from Ch. 121 1/2, par. 1202)

Sec. 2. Definitions. For the purposes of this Act, the
following words have the meanings ascribed to them in this
Section.

(a) "Consumer" means an individual who purchases or leases
for a period of at least one year a new vehicle from the seller
for the purposes of transporting himself and others, as well as
their personal property, for primarily personal, household or
family purposes or a fire department, fire protection district,
or township fire department that purchases or leases for a
period of at least one year a new vehicle from the seller.

(b) "Express warranty" has the same meaning, for the purposes of this Act, as it has for the purposes of the Uniform Commercial Code.

(c) "New vehicle" means a passenger car, as defined in
Section 1-157 of The Illinois Vehicle Code, a motor vehicle of
the Second Division having a weight of under 8,000 pounds, as
defined in Section 1-146 of that Code, <u>a vehicle purchased by a</u>

fire department, a fire protection district, or a township fire
department, and a recreational vehicle, except for a camping
trailer or travel trailer that does not qualify under the
definition of a used motor vehicle, as set forth in Section
1-216 of that Code.

6 (d) "Nonconformity" refers to a new vehicle's failure to 7 conform to all express warranties applicable to such vehicle, 8 which failure substantially impairs the use, market value or 9 safety of that vehicle.

10 (e) "Seller" means the manufacturer of a new vehicle, that 11 manufacturer's agent or distributor or that manufacturer's 12 authorized dealer. "Seller" also means, with respect to a new 13 vehicle which is also a modified vehicle, as defined in Section 14 1-144.1 of The Illinois Vehicle Code, as now or hereafter 15 amended, the person who modified the vehicle and that person's 16 agent or distributor or that person's authorized dealer. 17 "Seller" also means, with respect to leased new vehicles, the manufacturer, that manufacturer's agent or distributor or that 18 19 manufacturer's dealer, who transfers the right to possession 20 and use of goods under a lease.

(f) "Statutory warranty period" means the period of one year or 12,000 miles, whichever occurs first after the date of the delivery of a new vehicle to the consumer who purchased or leased it.

(g) "Lease cost" includes deposits, fees, taxes, down
 payments, periodic payments, and any other amount paid to a
