1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- disability rights movement. Instruction may be included in 1 2 those courses that the school district chooses. This 3 instruction must be founded on the principle that all students, including students with disabilities, have the right to 4 exercise self-determination. When possible, individuals with 5 disabilities should be incorporated into the development and 6 delivery of this instruction. This instruction may be 7 8 supplemented by knowledgeable quest speakers from the 9 disability community. A school board may collaborate with community-based organizations, such as centers for independent 10 11 living, parent training and information centers, and other 12 consumer-driven groups, and disability membership organizations in creating this instruction. 13
 - (b) The State Board of Education may prepare and make available to all school boards resource materials that may be used as quidelines for the development of instruction for disability history and awareness under this Section.
 - (c) Each school board shall determine the minimum amount of instructional time required under this Section.
