1 AMENDMENT TO HOUSE BILL 3641

2 AMENDMENT NO. _____. Amend House Bill 3641 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Illinois Public Aid Code is amended by
5 adding Section 12-4.37 as follows:

6 (305 ILCS 5/12-4.37 new)

7 Sec. 12-4.37. Children's Healthcare Partnership Pilot
8 Program.

9 (a) The Department of Healthcare and Family Services, in
10 cooperation with the Department of Human Services, shall
11 establish a Children's Healthcare Partnership Pilot Program in
12 Sangamon County to fund the provision of various health care
13 services by a single provider, or a group of providers that
14 have entered into an agreement for that purpose, at a single
15 location in the county. Services covered under the pilot
16 program shall include, but need not be limited to, family

1 practice, pediatric, nursing (including advanced practice
2 nursing), psychiatric, dental, and vision services. The
3 Departments shall fund the provision of all services provided
4 under the pilot program using a rate structure that is
5 cost-based. To be selected by the Departments as the provider
6 of health care services under the pilot program, a provider or
7 group of providers must serve a disproportionate share of
8 low-income or indigent patients, including recipients of
9 medical assistance under Article V of this Code. The
10 Departments shall adopt rules as necessary to implement this
11 Section.

12 (b) Implementation of this Section is contingent on federal
13 approval. The Department of Healthcare and Family Services
14 shall take appropriate action by January 1, 2010 to seek
15 federal approval.

16 (c) This Section is inoperative if the provider of health
17 care services under the pilot program receives designation as a
18 Federally Qualified Health Center (FQHC) or FQHC Look-Alike.

19 Section 10. The Community Services Act is amended by adding
20 Section 4.6 as follows:

21 (405 ILCS 30/4.6 new)

22 Sec. 4.6. Children's Healthcare Partnership Pilot Program.
23 The Department of Human Services shall participate in the
24 Children's Healthcare Partnership Pilot Program established

1 under Section 12-4.37 of the Illinois Public Aid Code and may
2 fund the provision of community services under this Act in
3 Sangamon County through participation in that pilot program.

4 Section 15. The Community Support Systems Act is amended by
5 adding Section 3.5 as follows:

6 (405 ILCS 35/3.5 new)

7 Sec. 3.5. Children's Healthcare Partnership Pilot Program.
8 The Department of Human Services shall participate in the
9 Children's Healthcare Partnership Pilot Program established
10 under Section 12-4.37 of the Illinois Public Aid Code and may
11 fund the provision of community support system services under
12 this Act in Sangamon County through participation in that pilot
13 program.

14 Section 99. Effective date. This Act takes effect upon
15 becoming law.".
