

1 AN ACT concerning education.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Higher Education Student Assistance Act is  
5 amended by changing Section 52 as follows:

6 (110 ILCS 947/52)

7 Sec. 52. Golden Apple Scholars of Illinois Program ~~Illinois~~  
8 ~~Future Teacher Corps Program.~~

9 (a) In order to encourage academically talented Illinois  
10 students, especially minority students, to pursue teaching  
11 careers, especially in teacher shortage disciplines (which  
12 shall be defined to include early childhood education) or at  
13 hard-to-staff schools (as defined by the Commission in  
14 consultation with the State Board of Education), to provide  
15 those students with the crucial mentoring, guidance, and  
16 in-service support that will significantly increase the  
17 likelihood that they will complete their full teaching  
18 commitments and elect to continue teaching in targeted  
19 disciplines and hard-to-staff schools, and to ensure that  
20 students in this State will continue to have access to a pool  
21 of highly-qualified teachers, the Commission shall combine the  
22 best practices and methods and programmatic functions of the  
23 Illinois Future Teacher Corps Program and the Golden Apple

1 Foundation for Excellence in Teaching's Golden Apple Scholars  
2 of Illinois Program into one program. The consolidated program  
3 shall be known as the Golden Apple Scholars of Illinois Program  
4 and shall be managed by the Golden Apple Foundation for  
5 Excellence in Teaching.

6 (1) This consolidated program shall be fully  
7 operational before July 1, 2012. The existing programs, the  
8 Illinois Future Teacher Corps Program and the Golden Apple  
9 Scholars Program, shall continue to exist and be governed  
10 as they have under this Section before the effective date  
11 of this amendatory Act of the 96th General Assembly and any  
12 associated administrative rules, but shall also begin a  
13 transition period commencing on the first day of the 2010  
14 fiscal year and ending on the last day of the 2013 fiscal  
15 year.

16 (2) During the transition period, the Commission  
17 shall, in consultation with the Golden Apple Foundation,  
18 establish rules governing the transition period and  
19 related fund transfers and to facilitate coordination and  
20 implementation of the consolidated program. Eligible  
21 students in this State may continue to apply for Illinois  
22 Future Teacher Corps scholarships under the current rules  
23 governing such applications during the transition period.  
24 Fiscal Year 2012 shall be the last year that such  
25 scholarships are available.

26 (3) The Commission shall, by March 30, 2010, develop an

1 estimate of General Revenue Funds that it expects will  
2 remain unexpended at the end of FY 2010 from the FY 2010  
3 appropriation for the Illinois Future Teacher Corps. No  
4 later than April 15, 2010, the Commission shall cause to be  
5 transferred funds comprising 85% of this estimated amount  
6 to the Golden Apple Foundation for Excellence in Teaching.  
7 The Commission shall subsequently transfer funding from  
8 the Illinois Future Teacher Corps Program to the Golden  
9 Apple Foundation for Excellence in Teaching on the  
10 following schedule and in the following amounts:

11 (A) FY 2011: an amount equal to 58% of the total  
12 combined appropriation for the Golden Apple Foundation  
13 for Excellence in Teaching and the Illinois Future  
14 Teacher Corps Program;

15 (B) FY 2012: an amount equal to 80% of the combined  
16 total appropriation for the Golden Apple Foundation  
17 for Excellence in Teaching and the Illinois Future  
18 Teacher Corps Program;

19 (C) FY 2013: the entire appropriation shall be  
20 designated for the Golden Apple Foundation for  
21 Excellence in Teaching.

22 (4) Following the consolidation of the 2 programs, at  
23 least 30% of Golden Apple Scholars of Illinois Program  
24 scholarships available each year shall be awarded to  
25 students residing in counties having a population of less  
26 than 500,000.

1           (5) Following the consolidation of the 2 programs, the  
2           Auditor General shall prepare an annual audit of the  
3           operations and finances of the Golden Apple Scholars of  
4           Illinois Program. This audit shall be provided to the  
5           Governor and the General Assembly.

6           (a-5) The, ~~the~~ Commission shall, each year until Fiscal  
7           Year 2011, receive and consider applications for scholarship  
8           assistance under this Section. An applicant is eligible for an  
9           Illinois Future Teacher Corps a scholarship under this Section  
10          when the Commission finds that the applicant is:

11                 (1) a United States citizen or eligible noncitizen;

12                 (2) a resident of Illinois;

13                 (3) a high school graduate or a person who has received  
14                 a General Educational Development Certificate;

15                 (4) enrolled or accepted for enrollment at or above the  
16                 junior level, on at least a half-time basis, at an Illinois  
17                 institution of higher learning; and

18                 (5) pursuing a postsecondary course of study leading to  
19                 initial certification or pursuing additional course work  
20                 needed to gain State Board of Education approval to teach,  
21                 including alternative teacher certification.

22           (b) Recipients shall be selected from among applicants  
23           qualified pursuant to subsection (a) based on a combination of  
24           the following criteria as set forth by the Commission until  
25           Fiscal Year 2011: (1) academic excellence; (2) status as a  
26           minority student as defined in Section 50; and (3) financial

1 need. Preference may be given to previous recipients of  
2 assistance under this Section, provided they continue to  
3 maintain eligibility and maintain satisfactory academic  
4 progress as determined by the institution of higher learning at  
5 which they enroll.

6 In each year until the consolidation of the 2 programs  
7 under subsection (a) of this Section has been completed, to  
8 support mentoring, guidance, and in-service support for  
9 teaching candidates in order to increase the likelihood that  
10 they will complete their full teaching commitments and elect to  
11 continue teaching in targeted disciplines and hard-to-staff  
12 schools, a minimum of 200 awards shall be allocated to  
13 participants in the Golden Apple Scholars of Illinois program.

14 (c) Each scholarship awarded under this Section shall be in  
15 an amount sufficient to pay the tuition and fees and room and  
16 board costs of the Illinois institution of higher learning at  
17 which the recipient is enrolled, up to an annual maximum of  
18 \$5,000; except that in the case of a recipient who does not  
19 reside on-campus at the institution of higher learning at which  
20 he or she is enrolled, the amount of the scholarship shall be  
21 sufficient to pay tuition and fee expenses and a commuter  
22 allowance, up to an annual maximum of \$5,000. For recipients  
23 who agree to teach in a teacher shortage discipline or at a  
24 hard-to-staff school under subsection (i) of this Section, the  
25 Commission may, by rule and subject to appropriation, increase  
26 the annual maximum amount to \$10,000. If a recipient agrees to

1 teach in both a teacher shortage discipline and at a  
2 hard-to-staff school under subsection (i) of this Section, the  
3 Commission may increase the amount of the scholarship awarded  
4 by up to an additional \$5,000.

5 (d) The total amount of scholarship assistance awarded by  
6 the Commission under this Section to an individual in any given  
7 fiscal year, when added to other financial assistance awarded  
8 to that individual for that year, shall not exceed the cost of  
9 attendance at the institution of higher learning at which the  
10 student is enrolled.

11 (e) A recipient may receive up to 4 semesters or 6 quarters  
12 of scholarship assistance under this Section.

13 (f) All applications for scholarship assistance to be  
14 awarded under this Section shall be made to the Commission in a  
15 form as set forth by the Commission. The form of application  
16 and the information required to be set forth therein shall be  
17 determined by the Commission, and the Commission shall require  
18 eligible applicants to submit with their applications such  
19 supporting documents as the Commission deems necessary.  
20 Notwithstanding any other provision of this Act, following the  
21 completion of the transition of funding of the Illinois Future  
22 Teacher Corps to the Golden Apple Foundation for Excellence in  
23 Teaching, all applications for scholarship assistance under  
24 this Section shall be in a form determined by the Golden Apple  
25 Foundation for Excellence in Teaching.

26 (g) Subject to a separate appropriation made for such

1 purposes, payment of any scholarship awarded under this Section  
2 shall be determined by the Commission. There shall be a  
3 separate appropriation made for scholarships awarded to  
4 recipients who agree to teach in a teacher shortage discipline  
5 or at a hard-to-staff school under subsection (i) of this  
6 Section. The Commission may use for scholarship assistance  
7 under this Section (i) all funds appropriated for scholarships  
8 under this Section that were formerly known as ITEACH Teacher  
9 Shortage Scholarships and (ii) all funds appropriated for  
10 scholarships under Section 65.65 of this Act (repealed by this  
11 amendatory Act of the 93rd General Assembly), formerly known as  
12 Illinois Future Teacher Corps Scholarships.

13 All scholarship funds distributed in accordance with this  
14 Section shall be paid to the institution on behalf of the  
15 recipients. Scholarship funds are applicable toward 2  
16 semesters or 3 quarters of enrollment within an academic year.

17 (h) The Commission shall administer the scholarship  
18 program established by this Section and shall make all  
19 necessary and proper rules not inconsistent with this Section  
20 for its effective implementation.

21 (i) Prior to receiving scholarship assistance for any  
22 academic year, each recipient of a scholarship awarded under  
23 this Section shall be required by the Commission to sign an  
24 agreement under which the recipient pledges that, within the  
25 one-year period following the termination of the academic  
26 program for which the recipient was awarded a scholarship, the

1 recipient: (i) shall begin teaching for a period of not less  
2 than 5 years, (ii) shall fulfill this teaching obligation at a  
3 nonprofit Illinois public, private, or parochial preschool or  
4 an Illinois public elementary or secondary school, and (iii)  
5 shall, upon request of the Commission, provide the Commission  
6 with evidence that he or she is fulfilling or has fulfilled the  
7 terms of the teaching agreement provided for in this  
8 subsection.

9 (j) If a recipient of a scholarship awarded under this  
10 Section fails to fulfill the teaching obligation set forth in  
11 subsection (i) of this Section, the Commission shall require  
12 the recipient to repay the amount of the scholarships received,  
13 prorated according to the fraction of the teaching obligation  
14 not completed, plus interest at a rate of 5% and if applicable,  
15 reasonable collection fees. The Commission is authorized to  
16 establish rules relating to its collection activities for  
17 repayment of scholarships under this Section. Payments  
18 received by the Commission under this subsection (j) shall be  
19 remitted to the State Comptroller for deposit into the General  
20 Revenue Fund, except that that portion of a recipient's  
21 repayment that equals the amount in expenses that the  
22 Commission has reasonably incurred in attempting collection  
23 from that recipient shall be remitted to the State Comptroller  
24 for deposit into the Commission's Accounts Receivable Fund.

25 (k) A recipient of a scholarship awarded by the Commission  
26 under this Section shall not be in violation of the agreement



1 entered into pursuant to subsection (i) if the recipient (i)  
2 enrolls on a full-time basis as a graduate student in a course  
3 of study related to the field of teaching at an institution of  
4 higher learning; (ii) is serving as a member of the armed  
5 services of the United States; (iii) is temporarily totally  
6 disabled, as established by sworn affidavit of a qualified  
7 physician; (iv) is seeking and unable to find full-time  
8 employment as a teacher at a school that satisfies the criteria  
9 set forth in subsection (i) and is able to provide evidence of  
10 that fact; (v) is taking additional courses, on at least a  
11 half-time basis, needed to obtain certification as a teacher in  
12 Illinois; or (vi) is fulfilling teaching requirements  
13 associated with other programs administered by the Commission  
14 and cannot concurrently fulfill them under this Section in a  
15 period of time equal to the length of the teaching obligation.  
16 Any such extension of the period during which the teaching  
17 requirement must be fulfilled shall be subject to limitations  
18 of duration as established by the Commission.

20 Section 10. The Illinois Vehicle Code is amended by  
21 changing Section 3-648 as follows:

22 (625 ILCS 5/3-648)

23 Sec. 3-648. Education license plates.

24 (a) The Secretary, upon receipt of an application made in

1 the form prescribed by the Secretary, may issue special  
2 registration plates designated as Education license plates.  
3 The special plates issued under this Section shall be affixed  
4 only to passenger vehicles of the first division and motor  
5 vehicles of the second division weighing not more than 8,000  
6 pounds. Plates issued under this Section shall expire according  
7 to the multi-year procedure established by Section 3-414.1 of  
8 this Code.

9 (b) The design and color of the plates shall be determined  
10 by a contest that every elementary school pupil in the State of  
11 Illinois is eligible to enter. The designs submitted for the  
12 contest shall be judged on September 30, 2002, and the winning  
13 design shall be selected by a committee composed of the  
14 Secretary, the Director of State Police, 2 members of the  
15 Senate, one member chosen by the President of the Senate and  
16 one member chosen by the Senate Minority Leader, and 2 members  
17 of the House of Representatives, one member chosen by the  
18 Speaker of the House and one member chosen by the House  
19 Minority Leader. The Secretary may allow the plates to be  
20 issued as vanity or personalized plates under Section 3-405.1  
21 of the Code. The Secretary shall prescribe stickers or decals  
22 as provided under Section 3-412 of this Code.

23 (c) An applicant for the special plate shall be charged a  
24 \$40 fee for original issuance, in addition to the appropriate  
25 registration fee. Of this \$40 additional original issuance fee,  
26 \$15 shall be deposited into the Secretary of State Special

1 License Plate Fund, to be used by the Secretary to help defray  
2 the administrative processing costs, and \$25 shall be deposited  
3 into the Illinois Future Teacher Corps Scholarship Fund. For  
4 each registration renewal period, a \$40 fee, in addition to the  
5 appropriate registration fee, shall be charged. Of this \$40  
6 additional renewal fee, \$2 shall be deposited into the  
7 Secretary of State Special License Plate Fund and \$38 shall be  
8 deposited into the Illinois Future Teacher Corps Scholarship  
9 Fund. Each fiscal year, once deposits from the additional  
10 original issuance and renewal fees into the Secretary of State  
11 Special License Plate Fund have reached \$500,000, all the  
12 amounts received for the additional fees for the balance of the  
13 fiscal year shall be deposited into the Illinois Future Teacher  
14 Corps Scholarship Fund.

15 (d) The Illinois Future Teacher Corps Scholarship Fund is  
16 created as a special fund in the State treasury. Ninety-five  
17 percent of the moneys in the Illinois Future Teacher Corps  
18 Scholarship Fund shall be appropriated to the Illinois Student  
19 Assistance Commission for scholarships under Section 52 of the  
20 Higher Education Student Assistance Act, and 5% of the moneys  
21 in the Illinois Future Teacher Corps Scholarship Fund shall be  
22 appropriated to the State Board of Education for grants to the  
23 Golden Apple Foundation for Excellence in Teaching, a  
24 recognized charitable organization that meets the requirements  
25 of Title 26, Section 501(c)(3) of the United States Code.  
26 Notwithstanding the other provisions of this subsection (d),

1 beginning in the 2010 fiscal year, funds for the Illinois  
2 Future Teacher Corps Program and the Golden Apple Foundation  
3 for Excellence in Teaching shall be apportioned according to  
4 Section 52 of the Higher Education Student Assistance Act.
