## HOUSE RESOLUTION

2 WHEREAS, Since 1952, the Chicago Blackhawks, a member of 3 the "Original Six" teams of the National Hockey League, have 4 played for almost half a century under the executive leadership 5 of Arthur Wirtz and his son, William "Bill" Wirtz, patriarchs 6 of Illinois professional sports; and

7 WHEREAS, In October 2007, Arthur Wirtz's grandson, William 8 Rockwell "Rocky" Wirtz, took over executive leadership of the 9 Chicago Blackhawks, a team already graced with the presence of 10 Dustin Byfuglien, Patrick Kane, Duncan Keith, Brent Seabrook, 11 future team captain Jonathan Toews, and many other future stars 12 and superstars of professional hockey; and

13 WHEREAS, Upon the base provided by these future superstars, 14 Rocky Wirtz has achieved one of the most dramatic achievements 15 of executive leadership in the history of the National Hockey 16 League; in November of 2007 he hired John McDonough as team 17 president of the Chicago Blackhawks; in of October 2008 he 18 hired Joe Quenneville as head coach; and in July of 2009 he 19 hired Stan Bowman as general manager; and

RESOLVED, 4 ΒY THE HOUSE OF REPRESENTATIVES OF THE 5 NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we 6 honor the sports ownership and executive leadership of William Rockwell "Rocky" Wirtz, owner of the Chicago Blackhawks 7 8 franchise, upon the hoisting by the Blackhawks of the 2009-10 9 Stanley Cup in acknowledgement of their position as the 10 champions of North American ice hockey; and be it further

11 RESOLVED, That we honor the entire Wirtz family, starting 12 with patriarch Arthur Wirtz, for their roles as owners in 13 Chicago professional sports, leaders of the Illinois business 14 community, and anchors and developers of Chicago's West Side; 15 and be it further

16 RESOLVED, That a suitable copy of this resolution be 17 presented to William Rockwell "Rocky" Wirtz as a token of our 18 appreciation for the leadership role of the Wirtz family, and 19 for the performance of excellence demonstrated by the Chicago 20 Blackhawks in 2010.
