Federal and State laws 14 15 prohibit a candidate whose name appears on the ballot (unless 16 you are the spouse or a parent, child, brother, or sister of 17 the candidate), your employer, your employer's agent or an officer or agent of your union from assisting physically 18 disabled voters." 19

In addition to the above, if a ballot to be provided to an elector pursuant to this Section contains a public question described in subsection (b) of Section 28-6 and the territory concerning which the question is to be submitted is not described on the ballot due to the space limitations of such ballot, the election authority shall provide a printed copy of a notice of the public question, which shall include a SB2022 Engrossed - 23 - LRB096 06039 JAM 16121 b
