A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to the Board
8 of the Trustees of Southern Illinois University to meet
9 ordinary and contingent expenses for the fiscal year ending
10 June 30, 2010:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2009-2010	192,662,100
18	For State Contributions to Social	
19	Security, for Medicare	2,358,500
20	For Group Insurance	3,685,700
21	For Contractual Services	12,625,700

8 Section 30. The sum of \$2,500,000, or so much thereof as
9 may be necessary, is appropriated from the General
10 Professions Dedicated Fund to the Board of Trustees of
11 Southern Illinois University for all costs associated with
12 the development, support or administration of pharmacy
13 practice education or training programs at the Edwardsville
14 campus.

15 Section 35. In addition to any other amounts
16 appropriated for such purposes, the following named amounts,
17 or so much thereof as may be necessary, are appropriated from
18 the General Revenue Fund to the Board of Trustees of Southern
19 Illinois University for the fiscal year beginning July 1,
20 2009, pursuant to Title XIV of the American Recovery and
21 Reinvestment Act of 2009:

 6 2009, pursuant to Title XIV (Other Government Services) of
 7 the American Recovery and Reinvestment Act of 2009:

9 Section 99. Effective date. This Act takes effect July 1,
 10 2009.
