1 AN ACT concerning liquor.

## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Liquor Control Act of 1934 is amended by 5 changing Section 6-15 as follows:

6 (235 ILCS 5/6-15) (from Ch. 43, par. 130)

Sec. 6-15. No alcoholic liquors shall be sold or delivered 7 8 in any building belonging to or under the control of the State 9 or any political subdivision thereof except as provided in this 10 corporate authorities of any city, village, Act. The incorporated town or township may provide by ordinance, 11 however, that alcoholic liquor may be sold or delivered in any 12 specifically designated building belonging to or under the 13 14 control of the municipality or township, or in any building located on land under the control of the municipality; provided 15 16 such township complies with all applicable local that 17 ordinances in any incorporated area of the township. Alcoholic liquor may be delivered to and sold under the authority of a 18 19 special use permit on any property owned by a conservation district organized under the Conservation District Act, 20 21 provided that (i) the alcoholic liquor is sold only at an event 22 authorized by the governing board of the conservation district, (ii) the issuance of the special use permit is authorized by 23

the local liquor control commissioner of the territory in which 1 2 the property is located, and (iii) the special use permit authorizes the sale of alcoholic liquor for one day or less. 3 Alcoholic liquors may be delivered to and sold at any airport 4 5 belonging to or under the control of a municipality of more 6 than 25,000 inhabitants, or in any building or on any golf course owned by a park district organized under the Park 7 8 District Code, subject to the approval of the governing board 9 of the district, or in any building or on any golf course owned 10 by a forest preserve district organized under the Downstate 11 Forest Preserve District Act, subject to the approval of the 12 governing board of the district, or on the grounds within 500 feet of any building owned by a forest preserve district 13 14 organized under the Downstate Forest Preserve District Act 15 during times when food is dispensed for consumption within 500 16 feet of the building from which the food is dispensed, subject 17 to the approval of the governing board of the district, or in a building owned by a Local Mass Transit District organized under 18 19 the Local Mass Transit District Act, subject to the approval of the governing Board of the District, or in Bicentennial Park, 20 or on the premises of the City of Mendota Lake Park located 21 22 adjacent to Route 51 in Mendota, Illinois, or on the premises 23 of Camden Park in Milan, Illinois, or in the community center owned by the City of Loves Park that is located at 1000 River 24 25 Park Drive in Loves Park, Illinois, or, in connection with the 26 operation of an established food serving facility during times

when food is dispensed for consumption on the premises, and at 1 2 the following aquarium and museums located in public parks: Art 3 Institute of Chicago, Chicago Academy of Sciences, Chicago Historical Society, Field Museum of Natural History, Museum of 4 5 Science and Industry, DuSable Museum of African American History, John G. Shedd Aquarium and Adler Planetarium, or at 6 7 Lakeview Museum of Arts and Sciences in Peoria, or in 8 connection with the operation of the facilities of the Chicago 9 Zoological Society or the Chicago Horticultural Society on land 10 owned by the Forest Preserve District of Cook County, or on any 11 land used for a golf course or for recreational purposes owned 12 by the Forest Preserve District of Cook County, subject to the 13 control of the Forest Preserve District Board of Commissioners 14 and applicable local law, provided that dram shop liability 15 insurance is provided at maximum coverage limits so as to hold 16 the District harmless from all financial loss, damage, and 17 harm, or in any building located on land owned by the Chicago Park District if approved by the Park District Commissioners, 18 or on any land used for a golf course or for recreational 19 20 purposes and owned by the Illinois International Port District if approved by the District's governing board, or at any 21 22 airport, golf course, faculty center, or facility in which 23 conference and convention type activities take place belonging to or under control of any State university or public community 24 25 college district, provided that with respect to a facility for 26 conference and convention type activities alcoholic liquors HB0079 Enrolled - 4 - LRB097 03968 ASK 44007 b

1 shall be limited to the use of the convention or conference 2 participants or participants in cultural, political or educational activities held in such facilities, and provided 3 further that the faculty or staff of the State university or a 4 5 public community college district, or members of an 6 organization of students, alumni, faculty or staff of the State 7 university or a public community college district are active 8 participants in the conference or convention, or in Memorial 9 Stadium on the campus of the University of Illinois at 10 Urbana-Champaign during games in which the Chicago Bears 11 professional football team is playing in that stadium during 12 the renovation of Soldier Field, not more than one and a half 13 hours before the start of the game and not after the end of the 14 third quarter of the game, or in the Pavilion Facility on the 15 campus of the University of Illinois at Chicago during games in 16 which the Chicago Storm professional soccer team is playing in 17 that facility, not more than one and a half hours before the start of the game and not after the end of the third guarter of 18 19 the game, or in the Pavilion Facility on the campus of the 20 University of Illinois at Chicago during games in which the 21 WNBA professional women's basketball team is playing in that 22 facility, not more than one and a half hours before the start 23 of the game and not after the 10-minute mark of the second half 24 of the game, or by a catering establishment which has rented 25 facilities from a board of trustees of a public community 26 college district, or in a restaurant that is operated by a

commercial tenant in the North Campus Parking Deck building 1 2 that (1) is located at 1201 West University Avenue, Urbana, Illinois and (2) is owned by the Board of Trustees of the 3 University of Illinois, or, if approved by the District board, 4 5 on land owned by the Metropolitan Sanitary District of Greater 6 Chicago and leased to others for a term of at least 20 years. Nothing in this Section precludes the sale or delivery of 7 8 alcoholic liquor in the form of original packaged goods in 9 premises located at 500 S. Racine in Chicago belonging to the 10 University of Illinois and used primarily as a grocery store by 11 a commercial tenant during the term of a lease that predates 12 University's acquisition of the premises; the but the University shall have no power or authority to renew, transfer, 13 or extend the lease with terms allowing the sale of alcoholic 14 15 liquor; and the sale of alcoholic liquor shall be subject to 16 all local laws and regulations. After the acquisition by 17 Winnebago County of the property located at 404 Elm Street in Rockford, a commercial tenant who sold alcoholic liquor at 18 19 retail on a portion of the property under a valid license at 20 the time of the acquisition may continue to do so for so long 21 as the tenant and the County may agree under existing or future 22 leases, subject to all local laws and regulations regarding the 23 sale of alcoholic liquor. Alcoholic liquors may be delivered to and sold at Memorial Hall, located at 211 North Main Street, 24 25 Rockford, under conditions approved by Winnebago County and subject to all local laws and regulations regarding the sale of 26

Alcoholic liquors may be sold at retail in 9 buildings of golf courses owned by municipalities in connection 10 with the operation of an established food serving facility 11 during times when food is dispensed for consumption upon the 12 premises. Alcoholic liquors may be delivered to and sold at 13 retail in any building owned by a fire protection district 14 organized under the Fire Protection District Act, provided that 15 such delivery and sale is approved by the board of trustees of 16 the district, and provided further that such delivery and sale 17 is limited to fundraising events and to a maximum of 6 events 18 per year.

Alcoholic liquors may be served or sold in buildings under 19 20 the control of the Board of Trustees of the University of Illinois for events that the Board may determine are public 21 22 events and not related student activities. The Board of 23 Trustees shall issue a written policy within 6 months of the effective date of this amendatory Act of the 95th General 24 25 Assembly concerning the types of events that would be eligible 26 for an exemption. In preparing its written policy, the Board of Trustees shall, among other factors it considers 3 relevant and important, give consideration to the following: 4 5 (i) whether the event is a student activity or student related 6 activity; (ii) whether the physical setting of the event is 7 conducive to control of liquor sales and distribution; (iii) 8 the ability of the event operator to ensure that the sale or 9 serving of alcoholic liquors and the demeanor of the 10 participants are in accordance with State law and University 11 policies; (iv) regarding the anticipated attendees at the 12 event, the relative proportion of individuals under the age of 13 21 to individuals age 21 or older; (v) the ability of the venue 14 operator to prevent the sale or distribution of alcoholic 15 liquors to individuals under the age of 21; (vi) whether the 16 event prohibits participants from removing alcoholic beverages 17 the venue; and (vii) whether the event prohibits from participants from providing their own alcoholic liquors to the 18 venue. In addition, any policy submitted by the Board of 19 20 Trustees to the Illinois Liquor Control Commission must require that any event at which alcoholic liquors are served or sold in 21 22 buildings under the control of the Board of Trustees shall 23 require the prior written approval of the Office of the Chancellor for the University campus where the event is 24 25 located. The Board of Trustees shall submit its policy, and any 26 subsequently revised, updated, new, or amended policies, to the

Alcoholic liquor may be delivered to and sold at retail in 4 5 the Dorchester Senior Business Center owned by the Village of Dolton if the alcoholic liquor is sold or dispensed only in 6 7 connection with organized functions for which the planned 8 attendance is 20 or more persons, and if the person or facility 9 selling or dispensing the alcoholic liquor has provided dram 10 shop liability insurance in maximum limits so as to hold 11 harmless the Village of Dolton and the State from all financial 12 loss, damage and harm.

Alcoholic liquors may be delivered to and sold at retail in any building used as an Illinois State Armory provided:

(i) the Adjutant General's written consent to the issuance of a license to sell alcoholic liquor in such building is filed with the Commission;

(iii) the organized function is one for which the

The Director of Natural Resources may specify conditions on that 6 7 including but not limited to requirements for approval, 8 insurance and hours of operation. Notwithstanding any other 9 provision of this Act, alcoholic liquor sold by a United States 10 Army Corps of Engineers or Department of Natural Resources 11 concessionaire who was operating on June 1, 1991 for 12 on-premises consumption only is not subject to the provisions 13 of Articles IV and IX. Beer and wine may be sold on the premises of the Joliet Park District Stadium owned by the 14 15 Joliet Park District when written consent to the issuance of a license to sell beer and wine in such premises is filed with 16 17 the local liquor commissioner by the Joliet Park District. Nothing in this Act shall prevent a not-for-profit organization or agency of the State from employing the services of a catering establishment for the selling or dispensing of alcoholic liquors at functions authorized by the Department of Central Management Services.

Alcoholic liquors may be sold or delivered in a building that is owned by McLean County, situated on land owned by the county in the City of Bloomington, and used by the McLean County Historical Society if the sale or delivery is approved HB0079 Enrolled - 21 - LRB097 03968 ASK 44007 b

by an ordinance adopted by the county board, and 1 the 2 municipality in which the building is located may not prohibit 3 that sale or delivery, notwithstanding any other provision of this Section. The regulation of the sale and delivery of 4 5 alcoholic liquor in a building that is owned by McLean County, 6 situated on land owned by the county, and used by the McLean 7 County Historical Society as provided in this paragraph is an exclusive power and function of the State and is a denial and 8 9 limitation under Article VII, Section 6, subsection (h) of the 10 Illinois Constitution of the power of a home rule municipality 11 to regulate that sale and delivery.

Alcoholic liquors may be sold or delivered in any building situated on land held in trust for any school district organized under Article 34 of the School Code, if the building is not used for school purposes and if the sale or delivery is approved by the board of education.

17 Alcoholic liquors may be sold or delivered in buildings 18 owned by the Community Building Complex Committee of Boone 19 County, Illinois if the person or facility selling or 20 dispensing the alcoholic liquor has provided dram shop 21 liability insurance with coverage and in amounts that the 22 Committee reasonably determines are necessary.

Alcoholic liquors may be sold or delivered in the building located at 1200 Centerville Avenue in Belleville, Illinois and occupied by either the Belleville Area Special Education District or the Belleville Area Special Services Cooperative. HB0079 Enrolled - 22 - LRB097 03968 ASK 44007 b

Alcoholic liquors may be delivered to and sold at the Louis Joliet Renaissance Center, City Center Campus, located at 214 N. Ottawa Street, Joliet, and the Food Services/Culinary Arts Department facilities, Main Campus, located at 1215 Houbolt Road, Joliet, owned by or under the control of Joliet Junior College, Illinois Community College District No. 525.

Alcoholic liquors may be delivered to and sold at Triton
College, Illinois Community College District No. 504.

9 Alcoholic liquors may be delivered to and sold at the 10 building located at 446 East Hickory Avenue in Apple River, 11 Illinois, owned by the Apple River Fire Protection District, 12 and occupied by the Apple River Community Association if the alcoholic liquor is sold or dispensed only in connection with 13 14 organized functions approved by the Apple River Community 15 Association for which the planned attendance is 20 or more 16 persons and if the person or facility selling or dispensing the 17 alcoholic liquor has provided dram shop liability insurance in maximum limits so as to hold harmless the Apple River Fire 18 19 Protection District, the Village of Apple River, and the Apple River Community Association from all financial loss, damage, 20 and harm. 21
