Section 5. The Illinois Insurance Code is amended by adding
Section 356z.3a as follows:

Notwithstanding any healthcare provider agreement with any 8 insurer or administrator, no group or individual policy of 9 accident and health insurance or managed care plan amended, 10 11 delivered, issued, or renewed after the effective date of this amendatory Act of the 97th General Assembly shall charge a 12 copayment that is more than 50% of the total billed charges for 13 14 services provided to an insured or enrollee during a visit to a healthcare provider. 15
