The Illinois Plumbing License Law is amended by 4 changing Sections 13.1, 16, and 42 as follows: 5 6 (225 ILCS 320/13.1) 7 13.1. Plumbing contractors; registration; Sec. 8 applications. (1) On and after May 1, 2002, all persons or corporations 9 10 desiring to engage in the business of plumbing contractor, other than any entity that maintains an audited net worth of 11 12 shareholders' equity equal to or exceeding \$100,000,000, shall 13 register in accordance with the provisions of this Act. (2) Application for registration shall be filed with the 14

Department each year, on or before the last day of September,

in writing and on forms prepared and furnished by the

- Department. All plumbing contractor registrations expire on the last day of September of each year.
 - (3) Applications shall contain the name, address, and telephone number of the person and the plumbing license of (i) the individual, if a sole proprietorship; (ii) the partner, if a partnership; or (iii) an officer, if a corporation. The application shall contain the business name, address, and telephone number, a current copy of the plumbing license, and any other information the Department may require by rule.
 - (4) Applicants shall submit an original certificate of insurance documenting that the contractor carries general liability insurance with a minimum of \$100,000 per occurrence, a minimum of \$300,000 aggregate for bodily injury, property damage insurance with a minimum of \$50,000 or a minimum of \$300,000 combined single limit, and workers compensation insurance with a minimum \$500,000 employer's liability. No registration may be issued in the absence of this certificate. Certificates must be in force at all times for registration to remain valid.
 - (5) Applicants shall submit, on a form provided by the Department, an indemnification bond in the amount of \$20,000 or a letter of credit in the same amount for work performed in accordance with this Act and the rules promulgated under this Act.
- 25 (6) All employees of a registered plumbing contractor who 26 engage in plumbing work shall be licensed plumbers or

- 1 apprentice plumbers in accordance with this Act.
- 2 (7) Plumbing contractors shall submit an annual registration fee in an amount to be established by rule.
 - (8) The Department shall be notified in advance of any changes in the business structure, name, or location or of the addition or deletion of the owner or officer who is the licensed plumber listed on the application. Failure to notify the Department of this information is grounds for suspension or revocation of the plumbing contractor's registration.
- 10 In the event that the plumber's license on the (9) 11 application for registration of a plumbing contractor is a license issued by the City of Chicago, it shall be the 12 13 responsibility of the applicant to forward a copy of plumber's license to the Department, noting the name of the 14 15 registered plumbing contractor, when it is renewed. In the 16 event that the plumbing contractor's registration is suspended or revoked, the Department shall notify the City of Chicago and 17 any corresponding plumbing contractor's license issued by the 18 City of Chicago shall be suspended or revoked. 19

Sec. 16. (1) Any city, village or incorporated town, having a population of 500,000 or more may, by an ordinance containing provisions substantially the same as those in this Act and

- and plumbing contractors shall, except as may otherwise be 3
- 4 provided within and pursuant to the provisions of Section 16
- 5 and Section 16.1 of this Act, be exercised by the State and may
- not be exercised by any unit of local government, including 6
- 7 home rule units.
