

97TH GENERAL ASSEMBLY State of Illinois 2011 and 2012 HB1334

SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-696 new

Amends the Illinois Vehicle Code. Provides for the issuance of Multiple Sclerosis Assistance license plates. Provides that in addition to the appropriate registration fees, an applicant for the special plate shall be charged a fee of \$25 at original issuance and \$12 at renewal. Provides that \$10 of the additional original issuance fee and the renewal fee shall be deposited into the Multiple Sclerosis Assistance Fund, a special fund in the State treasury. Provides that \$15 of the original issuance fee and \$2 of the renewal fee shall be deposited into the Secretary of State Special License Plate Fund. Effective immediately.

1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by adding Section 3-696 as follows:
- 6 (625 ILCS 5/3-696 new)
- 7 <u>Sec. 3-696. Multiple Sclerosis Assistance license plate.</u>
- (a) The Secretary, upon receipt of all applicable fees and 8 applications made in the form prescribed by the Secretary, may 10 issue special registration plates designated as Multiple Sclerosis Assistance license plates. The special plates issued 11 under this Section shall be affixed only to passenger vehicles 12 of the first division, motor vehicles of the second division 13 14 weighing not more than 8,000 pounds, recreational vehicles as defined by Section 1-169 of this Code, and boat trailers with a 15 gross trailer weight rating of 10,000 or less pounds. Plates 16 17 issued under this Section shall expire according to the multi-year procedure established by Section 3-414.1 of this 18 19 Code.
 - (b) The design and color of the special plates shall be wholly within the discretion of the Secretary. The Secretary, in his or her discretion, may allow the plates to be issued as vanity or personalized plates under Section 3-255.1 of this

- 1 <u>Code. The Secretary shall prescribe stickers or decals as</u>
- 2 provided under Section 3-412 of this Code.
- 3 (c) An applicant for the special plate shall be charged a
- 4 \$25 fee for original issuance in addition to the appropriate
- 5 registration fee. Of this fee, \$10 shall be deposited into the
- 6 Multiple Sclerosis Assistance Fund and \$15 shall be deposited
- 7 into the Secretary of State Special License Plate Fund, to be
- 8 used by the Secretary to help defray the administrative
- 9 processing costs.
- 10 For each registration renewal period, a \$12 fee, in
- addition to the appropriate registration fee, shall be charged.
- Of this fee, \$10 shall be deposited into the Multiple Sclerosis
- 13 Assistance Fund and \$2 shall be deposited into the Secretary of
- 14 State Special License Plate Fund.
- 15 Section 99. Effective date. This Act takes effect upon
- 16 becoming law.
