105 ILCS 5/2-3.66 from Ch. 122, par. 2-3.66

Amends the School Code. Makes a technical change in a Section concerning truants' alternative and optional education programs.

1 AN ACT concerning education.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The School Code is amended by changing Section
2-3.66 as follows:

6 (105 ILCS 5/2-3.66) (from Ch. 122, par. 2-3.66)

Sec. 2-3.66. Truants' alternative and optional education 7 8 programs. То establish projects to offer modified 9 instructional programs or other services designed to prevent 10 students from dropping out of school, including programs pursuant to Section 2-3.41, and and to serve as a part time or 11 full time option in lieu of regular school attendance and to 12 award grants to local school districts, educational service 13 14 regions or community college districts from appropriated funds to assist districts in establishing such projects. 15 The 16 education agency may operate its own program or enter into a 17 contract with another not-for-profit entity to implement the program. The projects shall allow dropouts, up to and including 18 19 age 21, potential dropouts, including truants, uninvolved, 20 unmotivated and disaffected students, as defined by State Board 21 Education rules and regulations, to enroll, as of an 22 alternative to regular school attendance, in an optional education program which may be established by school board 23

policy and is in conformance with rules adopted by the State 1 2 Truants' Alternative and Optional Board of Education. 3 Education programs funded pursuant to this Section shall be planned by a student, the student's parents or legal quardians, 4 5 unless the student is 18 years or older, and school officials and shall culminate in an individualized optional education 6 7 plan. Such plan shall focus on academic or vocational skills, 8 or both, and may include, but not be limited to, evening 9 school, summer school, community college courses, adult 10 education, preparation courses for the high school level test 11 of General Educational Development, vocational training, work 12 experience, programs to enhance self concept and parenting 13 courses. School districts which are awarded grants pursuant to 14 this Section shall be authorized to provide day care services 15 to children of students who are eligible and desire to enroll 16 in programs established and funded under this Section, but only 17 if and to the extent that such day care is necessary to enable those eligible students to attend and participate in the 18 programs and courses which are conducted pursuant to this 19 20 Section. School districts and regional offices of education may claim general State aid under Section 18-8.05 for students 21 22 enrolled in truants' alternative and optional education 23 programs, provided that such students are receiving services 24 that are supplemental to a program leading to a high school 25 diploma and are otherwise eligible to be claimed for general State aid under Section 18-8.05. 26
