

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1-5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to the

 21 Metropolitan Pier and Exposition Authority for debt service
 22 on the Authority's Dedicated State Tax Revenue Bonds, issued

1 pursuant to the "Metropolitan Fair and Exposition Authority
2 Act", as amended, and related trustee and legal expenses.

3 Section 4-10. The sum of \$126,729,100, or so much
4 thereof as may be necessary, is appropriated from the
5 McCormick Place Expansion Project Fund to the Metropolitan
6 Pier and Exposition Authority for debt service on the
7 Authority's McCormick Place Expansion Project Bonds, issued
8 pursuant to the "Metropolitan Pier and Exposition Authority
9 Act", as amended, and related trustee and legal expenses.

 7 may be necessary, is appropriated from the Illinois
 8 Firefighters' Memorial Fund to the Office of the State Fire
 9 Marshal for expenses related to the maintenance of the
 10 Illinois Firefighters' Memorial, holding the annual Fallen
 11 Firefighter Ceremony, and other expenses as allowed under
 12 Public Act 91-0832.

13 Section 5-25. The following named amounts, or so much
 14 thereof as may be necessary, respectively, are appropriated
 15 to the Office of the State Fire Marshal as follows:

2 Storage Tank Fund to the Office of the State Fire Marshal for
3 a grant to the City of Chicago for Administrative Costs
4 incurred as a result of the State's Underground Storage
5 Program.

6 Section 5-45. The sum of \$125,000, or so much thereof as
7 may be necessary, is appropriated from the Fire Prevention
8 Fund to the Office of the State Fire Marshal for grants
9 available for costs and services related to ILEAS/MABAS
10 administration.

12 Section 5-50. The sum of \$300,000, or so much thereof as
13 may be necessary, is appropriated from the Fire Prevention
14 Division Fund to the Office of the State Fire Marshal for
15 assistance to firefighters grant for smoke detectors for the
16 deaf and hard of hearing.
