

## 97TH GENERAL ASSEMBLY State of Illinois 2011 and 2012 HB3103

Introduced 2/23/2011, by Rep. Michael W. Tryon

## SYNOPSIS AS INTRODUCED:

25 ILCS 145/5.09

Amends the Legislative Information System Act. Requires that, on or before July 1, 2011, the floor roll calls taken by the House of Representatives and Senate and the roll calls taken by each of the committees of the House of Representatives and Senate must be posted on the General Assembly's website. Effective immediately.

1 AN ACT concerning State government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Legislative Information System Act is amended by changing Section 5.09 as follows:

- Sec. 5.09. Public computer access; legislative information. To make available to the public all of the following information in electronic form:
  - (1) On or before July 1, 1999, the weekly schedule of legislative floor sessions for each of the 2 houses of the General Assembly together with a list of matters pending before them and the weekly schedule of legislative committee hearings together with matters scheduled for their consideration.
    - (2) On or before July 1, 1999, a list of the committees of the General Assembly and their members.
    - (3) On or before July 1, 1999, the text of each bill and resolution introduced and of each engrossed, enrolled, and re-enrolled bill and resolution and the text of each adopted amendment and conference committee report.
- 22 (4) On or before July 1, 1999, a synopsis of items 23 specified in paragraph (3) of this Section, together with a

summary of legislative and gubernatorial actions regarding 1 2 each bill and resolution introduced. (5) On or before July 1, 1999, the Rules of the House 3 and the Senate of the General Assembly. 4 (5.5) On or before July 1, 2011, the floor roll calls taken by the House of Representatives and Senate. 6 7 (5.7) On or before July 1, 2011, the roll calls taken by each of the committees of the House of Representatives 8 9 and Senate. 10 (6) Before the conclusion of the Ninety-second General 11 Assembly, the text of Public Acts. 12 (7) Before the conclusion of the Ninety-second General Assembly, the Illinois Compiled Statutes. 13 (8) Before the conclusion of the Ninety-second General 14 15 Assembly, the Constitution of the United States and the 16 Constitution of the State of Illinois. 17 (9) Before the conclusion of the Ninety-second General Assembly, the text of the Illinois Administrative Code. 18 19 (10)Before the conclusion of the Ninety-second 20 General Assembly, the most current issue of the Illinois 21 Register published on or after the effective date of this 22 amendatory Act of 1998. 23 (11) Any other information that the Joint Committee on 24 Legislative Support Services elects to make available. 25 The information shall be made available to the public

through the World Wide Web. The information may also be made

- 1 available by any other means of access that would facilitate
- 2 public access to the information.
- 3 Any documentation that describes the electronic digital
- 4 formats of the information shall be made available through the
- 5 World Wide Web.
- 6 Personal information concerning a person who accesses this
- 7 public information may be maintained only for the purpose of
- 8 providing service to the person.
- 9 No fee or other charge may be imposed by the Legislative
- 10 Information System as a condition of accessing the information,
- 11 except that a reasonable fee may be charged for any customized
- 12 services and shall be deposited into the General Assembly
- 13 Computer Equipment Revolving Fund.
- 14 The electronic public access provided through the World
- 15 Wide Web shall be in addition to any other electronic or print
- distribution of the information.
- No action taken under this Section shall be deemed to alter
- or relinquish any copyright or other proprietary interest or
- 19 entitlement of the State of Illinois relating to any of the
- 20 information made available under this Section.
- 21 The information shall be made available as provided in this
- 22 Section in the shortest practicable time after it is publicly
- 23 available in any other form; provided that the System may make
- 24 information available under this Section only if the
- 25 availability in no way reduces the quality and timeliness of
- 26 service available to and required under this Act for

- 1 legislative users and does not unduly burden the General
- 2 Assembly or its support services agencies. Failure to provide
- 3 information under this Section does not affect the validity of
- 4 any action of the General Assembly. The General Assembly and
- 5 the State of Illinois are not liable for the accuracy,
- 6 availability, or use of the information provided under this
- 7 Section.
