1 AMENDMENT TO HOUSE BILL 3326

2 AMENDMENT NO. _____. Amend House Bill 3326 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Eminent Domain Act is amended by adding
5 Section 25-5-30 as follows:

6 (735 ILCS 30/25-5-30 new)

7 Sec. 25-5-30. Quick-take; Will County. Quick-take
8 proceedings under Article 20 may be used from March 1, 2011
9 until March 1, 2012 by Will County for the acquisition of
10 property to be used for the reconstruction of the Weber Road
11 (County Highway 88) and Renwick Road (County Highway 36)
12 intersection, as follows:

13 PARCEL 0001

14 The east 30.00 feet of that part of Lot 6 in McGilvray Acres,

1 being a subdivision of part of the Northeast Quarter of Section
2 19, Township 36 North, Range 10 East of the Third Principal
3 Meridian, according to the plat thereof recorded December 15,
4 1965, as Document No. R65-11631, lying southerly of a line
5 described as follows: Beginning at a point on the west line of
6 Lot 6, said point being 110.00 feet south of the north line of
7 said lot; thence southeasterly to a point on the east line of
8 said lot, said point being 114.00 feet south of the north line
