## SYNOPSIS AS INTRODUCED:

735 ILCS 30/25-5-30 new

Amends the Eminent Domain Act. Provides that quick-take proceedings may be used for a period of no longer than one year from the effective date by LaSalle County for the acquisition of land for the purpose of building roadways or other public improvements to serve LaSalle County. Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Eminent Domain Act is amended by adding Section 25-5-30 as follows:
(735 ILCS 30/25-5-30 new)
Sec. 25-5-30. Quick Take; LaSalle County. Quick-take proceedings under Article 20 may be used for a period of no longer than one year from the effective date of this amendatory Act of the 97th General Assembly by Lasalle County for the acquisition of the following described property for the purpose of building roadways or other public improvements to serve LaSalle County:
