1 AMENDMENT TO HOUSE BILL 4275 2 AMENDMENT NO. . Amend House Bill 4275 by replacing everything after the enacting clause with the following: 3 "Section 5. The School Code is amended by changing Sections 4 10-22.6, 13A-4, 13A-11, and 34-19 as follows: 5 6 (105 ILCS 5/10-22.6) (from Ch. 122, par. 10-22.6) 7 Sec. 10-22.6. Suspension or expulsion of pupils; school 8 searches. (a) To expel pupils guilty of gross disobedience or 9 10 misconduct, including gross disobedience or misconduct perpetuated by electronic means, and no action shall lie 11 12 against them for such expulsion. Expulsion shall take place 13 only after the parents have been requested to appear at a

meeting of the board, or with a hearing officer appointed by

it, to discuss their child's behavior. Such request shall be

made by registered or certified mail and shall state the time,

place and purpose of the meeting. The board, or a hearing officer appointed by it, at such meeting shall state the reasons for dismissal and the date on which the expulsion is to become effective. If a hearing officer is appointed by the board he shall report to the board a written summary of the evidence heard at the meeting and the board may take such action thereon as it finds appropriate. In school districts located in whole or in part within counties that have a municipality with a population of 500,000 or more, an expelled pupil must be immediately transferred to an alternative program in the manner provided in Article 13A or 13B of this Code, except those pupils expelled under the provisions of the federal Gun-Free Schools Act of 1994. In school districts located outside of counties that have a municipality with a population of 500,000 or more, an An expelled pupil may be immediately transferred to an alternative program in the manner provided in Article 13A or 13B of this Code. A pupil must not be denied transfer because of the expulsion, except in cases in which such transfer is deemed to cause a threat to the safety of students or staff in the alternative program.

(b) To suspend or by policy to authorize the superintendent of the district or the principal, assistant principal, or dean of students of any school to suspend pupils guilty of gross disobedience or misconduct, or to suspend pupils quilty of gross disobedience or misconduct on the school bus from riding the school bus, and no action shall lie against them for such

suspension. The may by policy authorize board the superintendent of the district or the principal, assistant principal, or dean of students of any school to suspend pupils quilty of such acts for a period not to exceed 10 school days. If a pupil is suspended due to gross disobedience or misconduct on a school bus, the board may suspend the pupil in excess of 10 school days for safety reasons. Any suspension shall be reported immediately to the parents or quardian of such pupil along with a full statement of the reasons for such suspension and a notice of their right to a review. The school board must be given a summary of the notice, including the reason for the suspension and the suspension length. Upon request of the parents or guardian the school board or a hearing officer appointed by it shall review such action of the superintendent or principal, assistant principal, or dean of students. At such review the parents or quardian of the pupil may appear and discuss the suspension with the board or its hearing officer. If a hearing officer is appointed by the board he shall report to the board a written summary of the evidence heard at the meeting. After its hearing or upon receipt of the written report of its hearing officer, the board may take such action as it finds appropriate. In school districts located in whole or in part within counties that have a municipality with a population of 500,000 or more, a pupil who is suspended in excess of 20 school days must be immediately transferred to an alternative program in the manner provided in Article 13A or

In school districts located outside of counties that have a municipality with a population of 500,000 2 3 or more, a A pupil who is suspended in excess of 20 school days 4 may be immediately transferred to an alternative program in the 5 manner provided in Article 13A or 13B of this Code. A pupil 6 must not be denied transfer because of the suspension, except in cases in which such transfer is deemed to cause a threat to 7 8 the safety of students or staff in the alternative program.
  - (c) The Department of Human Services shall be invited to send a representative to consult with the board at such meeting whenever there is evidence that mental illness may be the cause for expulsion or suspension.
  - (d) The board may expel a student for a definite period of time not to exceed 2 calendar years, as determined on a case by case basis. A student who is determined to have brought one of the following objects to school, any school-sponsored activity or event, or any activity or event that bears a reasonable relationship to school shall be expelled for a period of not less than one year:
    - (1) A firearm. For the purposes of this Section, "firearm" means any gun, rifle, shotgun, weapon as defined by Section 921 of Title 18 of the United States Code, firearm as defined in Section 1.1 of the Firearm Owners Identification Card Act, or firearm as defined in Section 24-1 of the Criminal Code of 1961. The expulsion period under this subdivision (1) may be modified by the

superintendent, and the superintendent's determination may be modified by the board on a case-by-case basis.

(2) A knife, brass knuckles or other knuckle weapon regardless of its composition, a billy club, or any other object if used or attempted to be used to cause bodily harm, including "look alikes" of any firearm as defined in subdivision (1) of this subsection (d). The expulsion requirement under this subdivision (2) may be modified by the superintendent, and the superintendent's determination may be modified by the board on a case-by-case basis.

Expulsion or suspension shall be construed in a manner consistent with the Federal Individuals with Disabilities Education Act. A student who is subject to suspension or expulsion as provided in this Section may be eligible for a transfer to an alternative school program in accordance with Article 13A of the School Code. The provisions of this subsection (d) apply in all school districts, including special charter districts and districts organized under Article 34.

(d-5) The board may suspend or by regulation authorize the superintendent of the district or the principal, assistant principal, or dean of students of any school to suspend a student for a period not to exceed 10 school days or may expel a student for a definite period of time not to exceed 2 calendar years, as determined on a case by case basis, if (i) that student has been determined to have made an explicit threat on an Internet website against a school employee, a

student, or any school-related personnel, (ii) the Internet website through which the threat was made is a site that was accessible within the school at the time the threat was made or was available to third parties who worked or studied within the school grounds at the time the threat was made, and (iii) the threat could be reasonably interpreted as threatening to the safety and security of the threatened individual because of his or her duties or employment status or status as a student inside the school. The provisions of this subsection (d-5)apply in all school districts, including special charter districts and districts organized under Article 34 of this Code.

(e) To maintain order and security in the schools, school authorities may inspect and search places and areas such as lockers, desks, parking lots, and other school property and equipment owned or controlled by the school, as well as personal effects left in those places and areas by students, without notice to or the consent of the student, and without a search warrant. As a matter of public policy, the General Assembly finds that students have no reasonable expectation of privacy in these places and areas or in their personal effects left in these places and areas. School authorities may request the assistance of law enforcement officials for the purpose of conducting inspections and searches of lockers, desks, parking lots, and other school property and equipment owned or controlled by the school for illegal drugs, weapons, or other

- illegal or dangerous substances or materials, including searches conducted through the use of specially trained dogs. If a search conducted in accordance with this Section produces evidence that the student has violated or is violating either the law, local ordinance, or the school's policies or rules, such evidence may be seized by school authorities, disciplinary action may be taken. School authorities may also turn over such evidence to law enforcement authorities. The provisions of this subsection (e) apply in all districts, including special charter districts and districts organized under Article 34.
  - (f) Suspension or expulsion may include suspension or expulsion from school and all school activities and a prohibition from being present on school grounds.
  - (g) A school district may adopt a policy providing that if a student is suspended or expelled for any reason from any public or private school in this or any other state, the student must complete the entire term of the suspension or expulsion in an alternative school program under Article 13A of this Code or an alternative learning opportunities program under Article 13B of this Code before being admitted into the school district if there is no threat to the safety of students or staff in the alternative program. This subsection (g) applies to all school districts, including special charter districts and districts organized under Article 34 of this Code.

4 Sec. 13A-4. Administrative transfers. In the case of a 5 student enrolled in the public schools of a school district organized under Article 34, in accordance with the uniform 6 system of discipline established under Section 34-19, or a 7 8 student enrolled in a school district located in whole or in 9 part within a county that has a municipality with a population 10 of 500,000 or more, a student who is determined to be subject to suspension or expulsion or who is suspended or expelled, in 11 the manner provided by Section 10-22.6, must be immediately 12 transferred to the alternative program. In all other cases, a A 13 14 student who is determined to be subject to suspension or 15 expulsion or who is suspended or expelled, in the manner provided by Section 10-22.6,  $\frac{10^{\circ}}{10^{\circ}}$  (or, in the case of a student 16 enrolled in the public schools of a school district organized 17 under Article 34, in accordance with the uniform system of 18 19 discipline established under Section 34-19) may be immediately 20 transferred to the alternative program. a municipality with a population of 500,000 or more, this request must be made by certified mail or delivered in person; state the date, time, place, and purpose of the meeting; and provide notice that the parents or quardians will be given an opportunity to speak regarding their expectations for the alternative education plan. The student may be invited. The alternative educational plan shall include, but not be limited to all of the following:

(1) The duration of the plan, including a date after which the student may be returned to the regular educational program in the public schools transferring district. If the parent or quardian of a student who is scheduled to be returned to the regular education program in the public schools of the district files a written objection to the return with the principal of the alternative school, the matter shall be referred by principal to the regional superintendent of the educational service region in which the alternative school program is located for a hearing. Notice of the hearing shall be given by the regional superintendent to the student's parent or quardian. After the hearing, regional superintendent may take such action as he or she finds appropriate and in the best interests of the student. The determination of the regional superintendent shall be final.

appropriated or expended, salaries shall be fixed or changed, electronic textbooks, and textbooks, and courses instruction shall be adopted or changed only at the regular meetings of the board and by a vote of a majority of the full membership of the board; provided that notwithstanding any other provision of this Article or the School Code, neither the board or any local school council may purchase any textbook for use in any public school of the district from any textbook publisher that fails to furnish any computer diskettes as required under Section 28-21.
