- 19 Section 45. The Western Illinois University Law is amended
- 20 by adding Section 35-180 as follows:

1	Sec. 35-180. Prohibitions with respect to employment. With
2	respect to hiring, the University is prohibited from
3	contracting with outside search firms, executive search firms,
4	or similar organizations. The University is prohibited from
5	hiring life coaches, executive counselors, or similar
6	individuals or groups.".
