SYNOPSIS AS INTRODUCED:

ILCON Art. VIII, Sec. 2

Proposes to amend the Finance Article of the Illinois Constitution concerning fiscal year budgets. Provides that the general fund expenditures in a fiscal year shall not exceed the amount of the general fund revenues in the immediately prior fiscal year. Effective upon being declared adopted.

11 FINANCE

- 13 SECTION 2. STATE FINANCE
- 14 (a) The Governor shall prepare and submit to the General 15 Assembly, at a time prescribed by law, a State budget for the ensuing fiscal year. The budget shall set forth the estimated 16 17 balance of funds available for appropriation at the beginning 18 of the fiscal year, the estimated receipts, and a plan for 19 expenditures and obligations during the fiscal year of every 20 department, authority, public corporation and quasi-public corporation of the State, every State college and university, 21 22 and every other public agency created by the State, but not of units of local government or school districts. The budget shall 23

- also set forth the indebtedness and contingent liabilities of
- 2 the State and such other information as may be required by law.
- 3 Proposed expenditures shall not exceed funds estimated to be
- 4 available for the fiscal year as shown in the budget.
- 5 (b) The General Assembly by law shall make appropriations
- 6 for all expenditures of public funds by the State.
- 7 Appropriations for a fiscal year shall not exceed funds
- 8 estimated by the General Assembly to be available during that
- 9 year. General fund expenditures in a fiscal year shall not
- 10 exceed the amount of the general fund revenues in the
- immediately prior fiscal year.
