2 WHEREAS, The members of the Illinois House of 3 Representatives are saddened to learn of the death of Miriam B. 4 Fry of Naperville, who passed away on January 17, 2011; and

5 WHEREAS, She was born March 22, 1917 in Wheeling; she was a 6 1935 graduate of Arlington Heights High School and a 1939 7 graduate of North Central College in Naperville, where she 8 received a Bachelor's degree in English; after college, Miriam 9 moved to Detroit, Michigan, where her husband, Arthur, worked 10 for General Motors; and

11 WHEREAS, After her husband passed away in 1945, the family 12 turned to Naperville; she started working at the Nichols 13 Library in the late 40's; she proudly served as Library 14 Director at Nichols Library from 1950-1984, a tenure which saw 15 tremendous growth for the library; she was later honored with 16 the establishment of The Miriam B. Fry Reading Room, which is 17 located in the new library; and
