### SYNOPSIS AS INTRODUCED:

625 ILCS 5/2-105

from Ch. 95 1/2, par. 2-105

Amends the Illinois Vehicle Code. Provides that Secretary of State driver facilities shall no longer be temporary places of voter registration, but rather permanent places of acceptance of voter registration applications. Deletes provisions governing the Secretary's powers and duties relating to voter registration and adds provisions governing the Secretary's powers and duties relating to acceptance of voter registration applications.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Vehicle Code is amended by changing
Section 2-105 as follows:

6 (625 ILCS 5/2-105) (from Ch. 95 1/2, par. 2-105)

7 Sec. 2-105. Offices of Secretary of State.

8 (a) The Secretary of State shall maintain offices in the 9 State capital and in such other places in the State as he may 10 deem necessary to properly carry out the powers and duties 11 vested in him.

(b) The Secretary of State may construct and equip one or 12 more buildings in the State of Illinois outside of the County 13 14 of Sangamon as he deems necessary to properly carry out the powers and duties vested in him. The Secretary of State may, on 15 16 behalf of the State of Illinois, acquire public or private 17 property needed therefor by lease, purchase or eminent domain. The care, custody and control of such sites and buildings 18 19 constructed thereon shall be vested in the Secretary of State. 20 Expenditures for the construction and equipping of any of such 21 buildings upon premises owned by another public entity shall 22 not be subject to the provisions of any State law requiring that the State be vested with absolute fee title to the 23

premises. The exercise of the authority vested in the Secretary of State by this Section is subject to the appropriation of the necessary funds.

(c) Pursuant to Section 1A-25 Sections 4-6.2, 5-16.2, and 4 5 6 50.2 of the Election Code, the Secretary of State shall make driver services facilities available for use as temporary 6 7 places of accepting applications for voter registration. Registration within the offices shall be in the most public, 8 9 orderly and convenient portions thereof, and Section 4 3, 5 3, 10 and 11 4 of the Election Code relative to the attendance of 11 police officers during the conduct of registration shall apply. 12 Registration under this Section shall be made in the manner provided by Sections 4-8, 4-10, 5-7, 5-9, 6-34, 6-35, and 6-37 13 of the Election Code. 14

(d) (Blank). Within 30 days after the effective date of 15 this amendatory Act of 1990, and no later than November 1 of 16 each even numbered year thereafter, the Secretary of State, to 17 the extent practicable, shall designate to each election 18 19 authority in the State a reasonable number of employees at each 20 driver services facility registered to vote within the 21 jurisdiction of such election authority and within adjacent 22 election jurisdictions for appointment as deputy registrars by the election authority located within the 23 election jurisdiction where the employees maintain their residences. 24 25 Such designation shall be in writing and certified by the 26 Secretary of State.

(e) Each person applying at a driver services facility for 1 2 a driver's license or permit, a corrected driver's license or permit, an Illinois identification card or a corrected Illinois 3 identification card shall be notified that the person may apply 4 to register to vote at such station to vote in the State and 5 may also apply to transfer his or her voter registration at 6 such station to a different address in the State. Such 7 8 notification may be made in writing or verbally issued by an 9 employee or the Secretary of State.

10 The Secretary of State shall promulgate such rules as may 11 be necessary for the efficient execution of his duties and the 12 duties of his employees under this <u>Section</u> <del>amendatory Act of</del> 13 <del>1990</del>.

(f) Any person applying at a driver services facility for 14 issuance or renewal of a driver's license or Illinois 15 16 Identification Card shall be provided, without charge, with a 17 brochure warning the person of the dangers of financial identity theft. The Department of Financial and Professional 18 Regulation shall prepare these brochures and provide them to 19 20 the Secretary of State for distribution. The brochures shall (i) identify signs warning the reader that he or she might be 21 22 an intended victim of the crime of financial identity theft, 23 (ii) instruct the reader in how to proceed if the reader believes that he or she is the victim of the crime of identity 24 25 theft, and (iii) provide the reader with names and telephone 26 numbers of law enforcement and other governmental agencies that
