- 1 AMENDMENT TO SENATE BILL 2022 2 AMENDMENT NO. . Amend Senate Bill 2022 by replacing 3 everything after the enacting clause with the following: "Section 5. The Limited Liability Company Act is amended by 4 changing Section 50-50 as follows: 5 6 (805 ILCS 180/50-50) 7 Sec. 50-50. Department of Business Services Special 8 Operations Fund. (a) A special fund in the State treasury is created and 9 10 shall be known as the Department of Business Services Special 11 Operations Fund. Moneys deposited into the Fund shall, subject 12 to appropriation, be used by the Department of Business 13 Services of the Office of the Secretary of State, hereinafter
- "Department", to create and maintain the capability to perform 14 15 expedited services in response to special requests made by the public for same-day or 24-hour service. Moneys deposited into 16

- 1 the Fund shall be used for, but not limited to, expenditures
- 2 for personal services, retirement, Social Security,
- 3 contractual services, equipment, electronic data processing,
- 4 and telecommunications.
- 5 (b) The balance in the Fund at the end of any fiscal year
- 6 shall not exceed \$600,000, and any amount in excess thereof
- 7 shall be transferred to the General Revenue Fund.
- 8 (c) All fees payable to the Secretary of State under this
- 9 Section shall be deposited into the Fund. No other fees or
- 10 charges collected under this Act shall be deposited into the
- 11 Fund.
- 12 (d) "Expedited services" means services rendered within
- 13 the same day, or within 24 hours from the time, the request
- 14 therefor is submitted by the filer, law firm, service company,
- or messenger physically in person or, at the Secretary of
- 16 State's discretion, by electronic means, to the Department's
- 17 Springfield Office and includes requests for certified copies,
- 18 photocopies, and certificates of good standing made to the
- 19 Department's Springfield Office in person or by telephone, or
- 20 requests for certificates of good standing made in person or by
- 21 telephone to the Department's Chicago Office.
- (e) Fees for expedited services shall be as follows:
- 23 Restated articles of organization, \$200;
- Merger or conversion, \$200;
- 25 Articles of organization, \$100;
- Articles of amendment, \$100;

- 1 Reinstatement, \$100;
- Application for admission to transact business, \$100; 2
- 3 Certificate of good standing or abstract of computer
- 4 record, \$20;
- 5 All other filings, copies of documents, annual reports, and
- copies of documents of dissolved or revoked limited liability 6
- companies, \$50; except that no expedited services fee shall be 7
- charged for annual reports filed on-line. 8
