2 AMENDMENT NO. _____. Amend Senate Bill 2408, AS
3 AMENDED, by replacing everything after the enacting clause with
4 the following:

5 "Section 5. "An Act making appropriations", Public Act 97-
6 56, approved June 30, 2011, is amended by changing Section 10
7 of Article 5 as follows:

8 (P.A. 97-56, Article 5, Section 10)

9 Sec. 10. The following named amounts, or so much thereof
10 as may be necessary, respectively, are appropriated to the
11 State Comptroller to pay certain appointed officers of the
12 Executive Branch of the State Government, at the various
13 rates prescribed by law:
