Amends the Illinois Fire Protection Training Act. Provides that the definition of "local governmental agency" includes the Office of the State Fire Marshal. Provides that if employees of the Office of the State Fire Marshal meet certain requirements, then they shall not be prohibited from receiving training certifications on the grounds that they are not employed or otherwise engaged by an organized Illinois fire department. Makes other changes.

AN ACT concerning local government.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Fire Protection Training Act is 5 amended by changing Sections 2, 9, and 10 as follows:

Sec. 2. Definitions. As used in this Act, unless the
context requires otherwise:

9 a. Office means the Office of the State Fire Marshal.

governmental agency" 10 b. "Local means anv local governmental unit or municipal corporation in this State. It 11 does not include the State of Illinois or any office, officer, 12 department, division, bureau, board, commission, or agency of 13 14 the State except: (i) a State controlled university, college, or public community college, or (ii) the Office of the State 15 16 Fire Marshal.

17 c. "School" means any school located within the State of 18 Illinois whether privately or publicly owned which offers a 19 course in fire protection training or related subjects and 20 which has been approved by the Office.

d. "Trainee" means a recruit fire fighter required to
 complete initial minimum basic training requirements at an
 approved school to be eligible for permanent employment as a

1 fire fighter.

e. "Fire protection personnel" and "fire fighter" means any person engaged in fire administration, fire prevention, fire suppression, fire education and arson investigation, including any permanently employed, trainee or volunteer fire fighter, whether or not such person, trainee or volunteer is compensated for all or any fraction of his time.

f. "Basic training" and "basic level" shall mean the Basic
Operations Firefighter program as promulgated by the rules and
regulations of the Office.

Training participation; funding. 13 Sec. 9. All local 14 governmental agencies and individuals may elect to participate in the training programs under this Act, subject to the rules 15 16 and regulations of the Office. The participation may be for certification only, or for certification and reimbursement for 17 18 training expenses as further provided in this Act. To be 19 eligible to receive reimbursement for training of individuals, 20 a local governmental agency shall require by ordinance that a 21 trainee complete a basic course approved by the Office, and 22 pass the State test for certification at the basic level within probationary period as 23 the established bv the local 24 governmental agency. A certified copy of the ordinance must be on file with the Office. 25

Individuals who have retired from active fire service 1 2 duties and are officially affiliated with fire service aid, incident 3 training, mutual command, fire ground operations, or staff support for public fire service 4 5 organizations shall not be prohibited from receiving training 6 certification from the Office on the ground that they are not 7 employed or otherwise engaged by an organized Illinois fire department if they otherwise meet the minimum certification 8 9 standards set by the Office.

Employees of the Office shall not be prohibited from receiving training certifications from the Office on the grounds that they are not employed or otherwise engaged by an organized Illinois fire department if they otherwise meet the minimum certification standards set by the Office and the certifications are directly related to their job-related duties, as determined by the Office.

17 The Office may by rule provide for reimbursement funding for trainees who are volunteers or paid on call fire protection 18 personnel beyond their probationary period, but not to exceed 3 19 20 years from the date of initial employment. The Office may 21 reimburse for basic or advanced training of individuals who 22 were permanently employed fire protection personnel prior to 23 the date of the ordinance. Individuals mav receive reimbursement if employed by a unit of local government that 24 25 participates for reimbursement funding and the individual is 26 otherwise eligible.

Failure of any trainee to complete the basic training and certification within the required period will render that individual and local governmental agency ineligible for reimbursement funding for basic training for that individual in the fiscal year in which his probationary period ends. The individual may later become certified without reimbursement.

7 Any participating local governmental agency may elect to 8 withdraw from the training program by repealing the original 9 ordinance, and a certified copy of the ordinance must be filed 10 with the Office.

13 Sec. 10. Training expenses; reimbursement. The Office, not 14 later than May 30th of each year, from funds appropriated for 15 this purpose, shall reimburse the local governmental agencies 16 or individuals participating in the training program in an amount equaling equalling one-half of the total sum paid by 17 them during the period established by the Office for tuition at 18 19 training schools, salary of trainees while in school, necessary 20 travel expenses, and room and board for each trainee. In 21 addition to reimbursement provided herein by the Office to the 22 local governmental agencies for participation by trainees, the Office in each year shall reimburse the local governmental 23 agencies participating in the training program for permanent 24 25 fire protection personnel in the same manner as trainees for SB3437 - 5 - LRB097 14453 KMW 59302 b

each training program. No more than 50% of the reimbursements 1 2 distributed to local governmental agencies in any fiscal year shall be distributed to local governmental agencies of more 3 than 500,000 persons. If at the time of the annual 4 5 reimbursement to local governmental agencies participating in 6 the training program there is an insufficient appropriation to 7 make reimbursement in full, the appropriation shall be 8 apportioned among the participating local governmental 9 agencies. No local governmental agency which shall alter or 10 change in any manner any of the training programs as 11 promulgated under this Act or fail to comply with rules and 12 regulations promulgated under this Act shall be entitled to 13 receive any matching funds under this Act. Submitting false information to the Office is a Class B misdemeanor. 14
