1 AN ACT concerning State government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Department of Veterans Affairs Act is amended by changing Sections 2 and 8 as follows:
- 6 (20 ILCS 2805/2) (from Ch. 126 1/2, par. 67)
- Sec. 2. Powers and duties. The Department shall have the following powers and duties:
  - To perform such acts at the request of any veteran, or his or her spouse, surviving spouse or dependents as shall be reasonably necessary or reasonably incident to obtaining or endeavoring to obtain for the requester any advantage, benefit or emolument accruing or due to such person under any law of the United States, the State of Illinois or any other state or governmental agency by reason of the service of such veteran, and in pursuance thereof shall:
    - (1) Contact veterans, their survivors and dependents and advise them of the benefits of state and federal laws and assist them in obtaining such benefits;
    - (2) Establish field offices and direct the activities of the personnel assigned to such offices;
- 22 (3) Create a volunteer field force of accredited 23 representatives, representing educational institutions,

labor organizations, veterans organizations, employers, 1 2 churches, and farm organizations; (4) Conduct informational and training services; 3 (5) Conduct educational programs through newspapers, periodicals and radio for the specific purpose of 6 disseminating information affecting veterans and their 7 dependents; (6) Coordinate the services and activities of all state 8 9 departments having services and resources affecting 10 veterans and their dependents; 11 (7) Encourage and assist in the coordination of 12 agencies within counties giving service to veterans and 13 their dependents; (8) Cooperate with veterans organizations and other 14 governmental agencies; 15 16 (9) Make, alter, amend and promulgate reasonable rules 17 and procedures for the administration of this Act; (10) Make and publish annual reports to the Governor 18 19 regarding the administration and general operation of the 20 Department; (11) (Blank); and 21 22 (12) (Blank). Conduct an annual review of the benefits received by Illinois veterans that compares 23 received by Illinois veterans with the benefits received by 24

veterans in all other states and U.S. territories. The

required annual review shall include, but not be

to, (1) the average benefit paid to individual veterans from Illinois, in direct comparison to the average benefit paid to individual veterans of each of the other states and U.S. territories; (2) the number of veterans receiving benefits in Illinois for the first time during the year compared to the number of claims filed by Illinois veterans during the year; (3) the aggregate number of Illinois veterans receiving benefits compared to the number veterans from each of the other states and U.S. territories receiving benefits; and (4) a categorical analysis of the types of injuries and disabilities for which benefits are being paid in Illinois and each of the other states and U.S. territories. The benefits review shall be reported to the Governor, the General Assembly, and the Illinois Congressional delegation upon the completion of the report each year.

The Department may accept and hold on behalf of the State, if for the public interest, a grant, gift, devise or bequest of money or property to the Department made for the general benefit of Illinois veterans, including the conduct of informational and training services by the Department and other authorized purposes of the Department. The Department shall cause each grant, gift, devise or bequest to be kept as a distinct fund and shall invest such funds in the manner provided by the Public Funds Investment Act, as now or hereafter amended, and shall make such reports as may be

- 1 required by the Comptroller concerning what funds are so held
- 2 and the manner in which such funds are invested. The Department
- 3 may make grants from these funds for the general benefit of
- 4 Illinois veterans. Grants from these funds, except for the
- 5 funds established under Sections 2.01a and 2.03, shall be
- 6 subject to appropriation.
- 7 The Department has the power to make grants, from funds
- 8 appropriated from the Korean War Veterans National Museum and
- 9 Library Fund, to private organizations for the benefit of the
- 10 Korean War Veterans National Museum and Library.
- 11 The Department has the power to make grants, from funds
- 12 appropriated from the Illinois Military Family Relief Fund, for
- benefits authorized under the Survivors Compensation Act.

- 16 Sec. 8. Post-Traumatic Stress Disorder Outpatient
- 17 Counseling Program. Subject to appropriations for that
- 18 purpose, the Department, in consultation with the Department of
- 19 Human Services, shall contract with professional counseling
- 20 specialists to provide a range of confidential counseling and
- 21 direct treatment services to war-affected Southwest Asia
- 22 combat veterans and their family members, and to provide
- 23 additional treatment services to Viet Nam War veterans for
- 24 post-traumatic stress disorder, particularly those Viet Nam
- 25 veterans whose post-traumatic stress disorder has intensified

- or initially emerged due to the war in the Middle East. Any such contracts entered into by the Department must be with individuals and entities pre-approved by the U.S. Department of Veterans Affairs and must be for the provision of services pre-approved by the U.S. Department of Veterans Affairs. In
- 6 consultation with the Department of Human Services, the 7 Department shall, to the extent funds are available:
  - (1) develop an educational program designed to inform and train primary health care professionals, including mental health professionals, about the effects of war-related stress and trauma;
  - (2) provide informational and counseling services for the purpose of establishing and fostering peer-support networks throughout the State for families of deployed members of the reserves and the Illinois National Guard; and
  - (3) provide for veterans' families a referral network of mental health providers who are skilled in treating deployment stress, combat stress, and post-traumatic stress.

As used in this Section, "Southwest Asia combat veteran" means an Illinois resident who is, or who was honorably discharged as, a member of the Armed Forces of the United States, a member of the Illinois National Guard, or a member of any reserve component of the Armed Forces of the United States and who served on active duty in connection with Operation

- Desert Storm, Operation Enduring Freedom, or Operation Iraqi 1
- 2 Freedom.
