3 Section 20. The amount of \$250,000, or so much thereof 4 as may be necessary, is appropriated from the Illinois 5 Military Family Relief Fund to the Department of Veterans' 6 Affairs for the payment of benefits authorized under the 7 Survivor's Compensation Act.

8 Section 25. The amount of \$150,000, or so much thereof 9 as may be necessary, is appropriated from the Illinois 10 Veterans' Homes Fund to the Department of Veterans' Affairs 11 to enhance the operations of veterans' homes in Illinois.

12 Section 30. The amount of \$150,000, or so much thereof 13 as may be necessary, is appropriated from the Disabled 14 Veterans Property Tax Relief Fund to the Department of 15 Veterans' Affairs for the purpose of providing property tax 16 relief to disabled veterans.

17 Section 35. The amount of \$8,300,000, or so much thereof 18 as may be necessary, is appropriated from the Illinois 19 Veterans Assistance Fund to the Department of Veterans' 20 Affairs for making grants, funding additional services, or 21 conducting additional research projects relating to veterans' post traumatic stress disorder; veterans' homelessness; the health insurance cost of veterans; veterans' disability benefits, including but not limited to, disability benefits provided by veterans service organizations and veterans assistance commissions or centers; and the long-term care of veterans.
