SYNOPSIS AS INTRODUCED:

220 ILCS 5/21-1251 new

Amends the Public Utilities Act. Provides that the Illinois Commerce Commission shall require all regulated cable service and video service providers under its authority to submit an annual report on all procurement goals and actual spending for minority-owned, women-owned, veteran-owned, and small business enterprises. Provides that each regulated cable service and video service provider shall submit the rules, regulations, and definitions used for its procurement goals and the name and contact information for the staff person responsible for administering the programs associated with the goals in the annual report. Provides that the Commission shall publish each annual report on its website and shall maintain each annual report for at least 5 years. Effective immediately.

Section 5. The Public Utilities Act is amended by adding

7 Sec. 21-1251. Minority, female, veteran, and small business reports and spending. The Commission shall require all 8 9 regulated cable service and video service providers under its authority to submit an annual report by December 1, 2014 and 10 each December 1 thereafter, in a searchable Adobe PDF format, 11 12 on all procurement goals and actual spending for minority-owned, women-owned, veteran-owned, and small business 13 14 enterprises in the previous calendar year. These goals shall be expressed as a percentage of the total work performed by the 15 16 regulated cable service and video service provider, and the 17 actual spending for all minority-owned, women-owned, veteran-owned, and small business enterprises shall be 18 19 expressed as a percentage of the total work performed by the 20 regulated cable and video provider.
