11 WHEREAS, He was a United States Army Veteran serving with 12 the 113th Engineers C Company, during World War II; he received 13 the Bronze Star for his bravery and heroism while engaged in 14 action in the Philippine Islands and 3 additional Bronze Battle 15 Stars, World War II Victory Medal, Asiatic-Pacific Theater 16 Ribbon, Philippine Liberation Ribbon, 3 Overseas Service Bars, 17 and one Service Stripe; and

18 WHEREAS, He was a life member of V.F.W.
