## SYNOPSIS AS INTRODUCED:

210 ILCS 55/2.08 210 ILCS 55/2.11 210 ILCS 55/2.12 rep.

Amends the Home Health, Home Services, and Home Nursing Agency Licensing Act. In the definitions of "home services agency" and "home nursing agency", removes language referring to such an agency that acts as a placement agency. Repeals a provision defining "placement agency".

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Home Health, Home Services, and Home Nursing

  Agency Licensing Act is amended by changing Sections 2.08 and

  2.11 as follows:
- 7 (210 ILCS 55/2.08)

Sec. 2.08. "Home services agency" means an agency that 8 9 provides services directly, or acts as a placement agency, for 10 the purpose of placing individuals as workers providing home services for consumers in their personal residences. "Home 11 services agency" does not include agencies licensed under the 12 Nurse Agency Licensing Act, the Hospital Licensing Act, the 13 14 Nursing Home Care Act, the ID/DD Community Care Act, the Specialized Mental Health Rehabilitation Act, or the Assisted 15 16 Living and Shared Housing Act and does not include an agency 17 t.hat. limits its business exclusively to providing 18 housecleaning services. Programs providing services 19 exclusively through the Community Care Program of the Illinois Department on Aging, the Department of Human Services Office of 20 21 Rehabilitation Services, or the United States Department of Veterans Affairs are not considered to be a home services 22 agency under this Act. 23

- 5 Sec. 2.11. "Home nursing agency" means an agency that
- 6 provides services directly, or acts as a placement agency, in
- 7 order to deliver skilled nursing and home health aide services
- 8 to persons in their personal residences. A home nursing agency
- 9 provides services that would require a licensed nurse to
- 10 perform. Home health aide services are provided under the
- 11 direction of a registered professional nurse or Advanced
- 12 Practice nurse. A home nursing agency does not require
- 13 licensure as a home health agency under this Act. "Home nursing
- 14 agency" does not include an individually licensed nurse acting
- as a private contractor or a person that provides or procures
- temporary employment in health care facilities, as defined in
- 17 the Nurse Agency Licensing Act.
