- 13 signs of mental illness and suicidal behavior in adolescents
- 14 and teens and shall be taught appropriate intervention and

- school personnel who work with pupils may be trained to have a
- 18 basic knowledge of matters relating to acquired

- At least once every 2 years, an in-service training program 18
