

## 98TH GENERAL ASSEMBLY State of Illinois 2013 and 2014 HB3337

## SYNOPSIS AS INTRODUCED:

20 ILCS 405/405-335

Amends the Department of Central Management Services Law of the Civil Administrative Code of Illinois. In the Illinois Transparency and Accountability Portal (ITAP) provisions, redefines a "State agency" to which the provisions apply to include the General Assembly and the legislative support services agencies.

1 AN ACT concerning State government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The Department of Central Management Services
- 5 Law of the Civil Administrative Code of Illinois is amended by
- 6 changing Section 405-335 as follows:
- 7 (20 ILCS 405/405-335)
- 8 Sec. 405-335. Illinois Transparency and Accountability
- 9 Portal (ITAP).
- 10 (a) The Department, within 12 months after the effective
- date of this amendatory Act of the 96th General Assembly, shall
- 12 establish and maintain a website, known as the Illinois
- 13 Transparency and Accountability Portal (ITAP), with a
- 14 full-time webmaster tasked with compiling and updating the ITAP
- database with information received from all State agencies as
- 16 defined in this Section. Subject to appropriation, the
- 17 full-time webmaster must also compile and update the ITAP
- 18 database with information received from all counties,
- 19 townships, and municipalities.
- 20 (b) For purposes of this Section:
- 21 "State agency" means the offices of the constitutional
- officers identified in Article V of the Illinois Constitution,
- 23 executive agencies, and departments, boards, commissions, and

- 2 the General Assembly and the legislative support services
- 3 agencies.
- 4 "Contracts" means payment obligations with vendors on file
- 5 with the Office of the Comptroller to purchase goods and
- 6 services exceeding \$10,000 in value (or, in the case of
- 7 professional or artistic services, exceeding \$5,000 in value).
- 8 "Appropriation" means line-item detail of spending
- 9 approved by the General Assembly and Governor, categorized by
- 10 object of expenditure.
- "Individual consultants" means temporary workers eligible
- to receive State benefits paid on a State payroll.
- "Recipients" means State agencies receiving
- 14 appropriations.
- 15 (c) The ITAP shall provide direct access to each of the
- 16 following:
- 17 (1) A database of all current State employees and
- 18 individual consultants, except sworn law enforcement
- officers, sorted separately by:
- 20 (i) Name.
- 21 (ii) Employing State agency.
- 22 (iii) Employing State division.
- 23 (iv) Employment position title.
- (v) Current pay rate and year-to-date pay.
- 25 (2) A database of all current State expenditures,
- sorted separately by agency, category, recipient, and

1 Representative District.

- (3) A database of all development assistance reportable pursuant to the Corporate Accountability for Tax Expenditures Act, sorted separately by tax credit category, taxpayer, and Representative District.
- (4) A database of all revocations and suspensions of State occupation and use tax certificates of registration and all revocations and suspensions of State professional licenses, sorted separately by name, geographic location, and certificate of registration number or license number, as applicable. Professional license revocations and suspensions shall be posted only if resulting from a failure to pay taxes, license fees, or child support.
- (5) A database of all current State contracts, sorted separately by contractor name, awarding officer or agency, contract value, and goods or services provided.
- (6) A database of all employees hired after the effective date of this amendatory Act of 2010, sorted searchably by each of the following at the time of employment:
  - (i) Name.
  - (ii) Employing State agency.
- (iii) Employing State division.
- 24 (iv) Employment position title.
  - (v) Current pay rate and year-to-date pay.

2	(viii) Status of position as subject to collective
3	bargaining, subject to merit compensation, or exempt
4	under Section 4d of the Personnel Code.
5	(ix) Employment status as probationary, trainee,
6	intern, certified, or exempt from certification.
7	(x) Status as a military veteran.
8	(7) A searchable database of all current county,
9	township, and municipal employees sorted separately by:
10	(i) Employing unit of local government.
11	(ii) Employment position title.
12	(iii) Current pay rate and year-to-date pay.
13	(8) A searchable database of all county, township, and
14	municipal employees hired on or after the effective date of
15	this amendatory Act of the 97th General Assembly, sorted
16	separately by each of the following at the time of
17	employment:
18	(i) Employing unit of local government.
19	(ii) Employment position title.
20	(iii) Current pay rate and year-to-date pay.
21	(d) The ITAP shall include all information required to be
22	published by subsection (c) of this Section that is available
23	to the Department in a format the Department can compile and
24	publish on the ITAP. The Department shall update the ITAP as
25	additional information becomes available in a format that can

be compiled and published on the ITAP by the Department.

- 1 (e) Each State agency, county, township, and municipality
- 2 shall cooperate with the Department in furnishing the
- 3 information necessary for the implementation of this Section
- 4 within a timeframe specified by the Department.
- 5 (f) Each county, township, or municipality submitting
- 6 information to be displayed on the Illinois Transparency and
- 7 Accountability Portal (ITAP) is responsible for the accuracy of
- 8 the information provided.
