SYNOPSIS AS INTRODUCED:

30 ILCS 537/25 30 ILCS 537/90 rep.

Amends the Design-Build Procurement Act. Provides that the committee shall consist of at least 5 but no more than 7 members. Provides that public members shall be nominated within 30 days of receiving notice. Adds that if either group fails to nominate a suitable candidate within the 30 day period, the State construction agency shall nominate an appropriate public member. Provides that if a conflict of interest is discovered before proposals are reviewed, the member with the conflict shall be removed and the committee may continue with only one public member. Removes a Section that repeals the Act on July 1, 2014.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

- Section 5. The Design-Build Procurement Act is amended by
 changing Section 25 as follows:
- 6 (30 ILCS 537/25)
- 7 (Section scheduled to be repealed on July 1, 2014)
- 8 Sec. 25. Selection committee.

9 (a) When the State construction agency elects to use the design-build delivery method, it shall establish a committee to 10 evaluate and select the design-build entity. The committee, 11 under the discretion of the State construction agency, shall 12 consist of at least 5 b<u>ut no more than</u> or 7 members and shall 13 14 include at least one licensed design professional and 2 members of the public. Public members may not be employed or associated 15 16 with any firm holding a contract with the State construction 17 agency. Within 30 days of receiving notice, one One public member shall be nominated by associations representing the 18 19 general design or construction industry and one member shall be minority 20 associations that represent nominated by or 21 female-owned design or construction industry businesses. If 22 either group fails to nominate a suitable candidate within the 30 day period, the State construction agency shall nominate an 23

<u>appropriate public member.</u> The selection committee may be
 designated for a set term or for the particular project subject
 to the request for proposal.

(b) The members of the selection committee must certify for
each request for proposal that no conflict of interest exists
between the members and the design-build entities submitting
proposals. If a conflict <u>is discovered before proposals are</u>
<u>reviewed exists</u>, the member must be replaced before any review
of proposals.

10 <u>If a conflict is discovered after proposals are reviewed,</u> 11 <u>the member with the conflict shall be removed and the committee</u> 12 <u>may continue with only one public member.</u>

13If at least 5 members remain, the remaining committee14members may complete the selection process.
