AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented 2 in the General Assembly: 3

Section 5. The following named amounts, or so much of 4 those amounts as may be necessary, respectively, for the 5 6 objects and purposes hereinafter named, are appropriated from 7 the General Revenue Fund to meet the ordinary and contingent 8 expenses of the Office of the State Appellate Defender:

Section 10. The amount of \$200,000, or so much thereof as 20 may be necessary, is appropriated from the State Appellate 21

5 Section 15. The amount of \$65,000, or so much thereof as 6 may be necessary, is appropriated from the General Revenue 7 Fund to the Office of the State Appellate Defender for 8 expenses related to federally assisted programs to work on 9 systemic sentencing issues appeals cases to which the agency 10 is appointed.

Section 20. The amount of \$175,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Office of the State Appellate Defender for the ordinary and contingent expenses of the Expungement Program.

15 Section 25. The amount of \$63,000, or so much thereof as 16 may be necessary, is appropriated from the General Revenue 17 Fund to the Office of the State Appellate Defender to provide 18 statewide training to Public Defenders under the Public 19 Defender Training Program.

20 Section 30. The amount of \$300,000, or so much thereof as 21 may be necessary, is appropriated from the General Revenue HB3504 -3- LRB098 11272 JDS 42388 b 1 Fund to the Office of the State Appellate Defender to develop 2 a Juvenile Defender Resource Center.

3 Section 99. Effective date. This Act takes effect July 1,
