AMENDMENT TO HOUSE BILL 3946

AMENDMENT NO. _____. Amend House Bill 3946 by replacing everything after the enacting clause with the following:

"Section 5. The Family Practice Residency Act is amended by changing Sections 2, 3, and 4.10 and by adding Section 3.09 as

Sec. 2. The purpose of this Act is to establish programs a program in the Illinois Department of Public Health to upgrade primary health care services for all citizens of the State, to increase access, and to reduce health care disparities by providing grants to family practice and preventive medicine residency programs, scholarships to medical students, and a loan repayment program for physicians and other eligible primary care providers who will agree to practice in areas of the State demonstrating the greatest need for more professional

- 1 medical care. The programs program shall encourage family
- practice physicians and other eligible primary care providers 2
- 3 to locate in areas where health manpower shortages exist and to
- 4 increase the total number of family practice physicians and

Payments under this program may be made for the 1 2 principal, interest and related expenses of government and 3 commercial loans received by the individual for tuition 4 expenses, and all other reasonable educational expenses 5 incurred by the individual. The maximum annual payment which 6 may be made to an individual under this law is \$20,000, or 25% 7 of the total covered educational indebtedness as provided in this Section, whichever is less. Payments made under this 8 9 provision shall be exempt from Illinois State Income Tax. The 10 Department may use tobacco settlement recovery funding or other 11 available funding to implement this Section.
