AN ACT concerning regulation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Dental Practice Act is amended by 5 changing Section 8.1 as follows:

licensed dentist shall 10 (a) No administer general anesthesia, deep sedation, or conscious sedation without first 11 applying for and and obtaining a permit for such purpose from 12 13 the Department. The Department shall issue such permit only 14 after ascertaining that the applicant possesses the minimum qualifications necessary to protect public safety. A person 15 16 with a dental degree who administers anesthesia, deep sedation, 17 or conscious sedation in an approved hospital training program under the supervision of either a licensed dentist holding such 18 19 permit or a physician licensed to practice medicine in all its 20 branches shall not be required to obtain such permit.

(b) In determining the minimum permit qualifications that are necessary to protect public safety, the Department, by rule, shall: HB3996

1 (1) establish the minimum educational and training 2 requirements necessary for a dentist to be issued an 3 appropriate permit;

4 (2) establish the standards for properly equipped 5 dental facilities (other than licensed hospitals and 6 ambulatory surgical treatment centers) in which general 7 anesthesia, deep sedation, or conscious sedation is 8 administered, as necessary to protect public safety;

9 (3) establish minimum requirements for all persons who 10 assist the dentist in the administration of general 11 anesthesia, deep sedation, or conscious sedation, 12 including minimum training requirements for each member of 13 the dental team, monitoring requirements, recordkeeping 14 requirements, and emergency procedures; and

(4) ensure that the dentist and all persons assisting
the dentist or monitoring the administration of general
anesthesia, deep sedation, or conscious sedation maintain
current certification in Basic Life Support (BLS).

(5) establish continuing education requirements in
 sedation techniques for dentists who possess a permit under
 this Section.

22 establishing requirements under this Section, When the 23 shall consider the current American Department Dental Association guidelines on sedation and general anesthesia, the 24 25 current "Guidelines for Monitoring and Management of Pediatric 26 Patients During and After Sedation for Diagnostic and 1 Therapeutic Procedures" established by the American Academy of 2 Pediatrics and the American Academy of Pediatric Dentistry, and 3 the current parameters of care and Office Anesthesia Evaluation 4 (OAE) Manual established by the American Association of Oral 5 and Maxillofacial Surgeons.

6 (c) A licensed dentist must hold an appropriate permit 7 issued under this Section in order to perform dentistry while a 8 nurse anesthetist administers conscious sedation, and a valid 9 written collaborative agreement must exist between the dentist 10 and the nurse anesthetist, in accordance with the Nurse 11 Practice Act.

A licensed dentist must hold an appropriate permit issued under this Section in order to perform dentistry while a nurse anesthetist administers deep sedation or general anesthesia, and a valid written collaborative agreement must exist between the dentist and the nurse anesthetist, in accordance with the Nurse Practice Act.

For the purposes of this subsection (c), "nurse anesthetist" means a licensed certified registered nurse anesthetist who holds a license as an advanced practice nurse. (Source: P.A. 95-399, eff. 1-1-08; 95-639, eff. 1-1-08; 96-328, eff. 8-11-09.)
