SYNOPSIS AS INTRODUCED:

50 ILCS 205/20 new 30 ILCS 805/8.38 new

Amends the Local Records Act. Provides that every park district that maintains an Internet website must post to its website a list of total compensation paid to each employee and whether that employee is an elected official. Requires park districts without a website to make the same information available to the public in its main office. Limits home rule powers. Amends the State Mandates Act to require implementation without reimbursement.

HOME RULE NOTE ACT MAY APPLY

STATE MANDATES ACT MAY REQUIRE REIMBURSEMENT 1 AN ACT concerning local government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Local Records Act is amended by adding Section 20 as follows:
- 6 (50 ILCS 205/20 new)
- 7 <u>Sec. 20. Park district posting requirements.</u>
- 8 (a) Every park district that maintains an Internet website 9 shall, within 90 days of the effective date of this amendatory
- 10 Act of the 98th General Assembly, post to its website for the
- 11 <u>current calendar year a detailed list of the total compensation</u>
- 12 paid to each employee including wages, salary, overtime, and
- benefits, including health, dental, life, and pension, and

- Sec. 8.38. Exempt mandate. Notwithstanding Sections 6 and 8
- of this Act, no reimbursement by the State is required for the
- implementation of any mandate created by this amendatory Act of
- 18 the 98th General Assembly.
