- 7 <u>Sec. 699.14. Yellow Ribbon license plates.</u>
- (a) Legislative Finding. Since as early as the Civil War, 8 the Yellow Ribbon has been a symbol of remembrance for men and women who serve their country far away from home. The Yellow 10 Ribbon represents our longing and devotion for our loved ones, 11 12 who risk their lives for our freedom, to safely return home; and our dedication to continue to serve and honor our heroes 13 14 upon their return. A portion of the revenues generated from the Yellow Ribbon plate will be deposited into the Illinois 15 Veterans Assistance Fund to ensure continued commitment to 16
 - (b) The Secretary, upon receipt of all applicable fees and applications made in the form prescribed by the Secretary, may issue special registration plates designated as Yellow Ribbon license plates. The special plates issued under this Section shall be affixed only to passenger vehicles of the first

- into the Secretary of State Special License Plate Fund, to be 18
