Amend House Bill 5785 as follows: 3 on page 1, immediately below line 16, by inserting: "The employees of the former district shall be transferred 4 5 to the governmental unit assuming the functions of the former district. The governmental unit assuming the functions of the 6 7 former district shall exercise the rights and responsibilities of the former district with respect to those employees.
