A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, are appropriated
7 for the ordinary and contingent expenses of the Office of the
8 State Fire Marshal, as follows:

20 Section 5. The sum of \$775,000, or so much thereof as
 21 may be necessary, is appropriated from the Fire Prevention
 22 Fund to the Office of the State Fire Marshal for costs and
 23 expenses related to or in support of a public safety shared
 24 services center.

1 Section 10. The sum of \$65,000, or so much thereof as
 2 may be necessary, is appropriated from the Fire Prevention
 3 Fund to the Office of the State Fire Marshal for costs and
 4 expenses related to or in support of the Fire Explorer and
 5 Cadet School.

6 Section 15. The sum of \$200,000, or so much thereof as
 7 may be necessary, is appropriated from the Illinois
 8 Firefighters' Memorial Fund to the Office of the State Fire
 9 Marshal for expenses related to the maintenance of the
 10 Illinois Firefighters' Memorial, holding the annual Fallen
 11 Firefighter Ceremony, and other expenses as allowed under
 12 Public Act 91-0832.

13 Section 20. The following named amounts, or so much
 14 thereof as may be necessary, respectively, are appropriated
 15 to the Office of the State Fire Marshal as follows:

16 Payable from the Fire Prevention Fund:

17 For Expenses of senior officer training55,000
 18 For Expenses of the Risk Watch/Remember
 19 When program10,000
 20 For Expenses related to fire prevention training25,000
 21 For Expenses of Firefighter Testing
 22 and Training Audits150,000

1 Payable from the Fire Prevention Division Fund:
 2 For Expenses of the U.S. Resource
 3 Conservation and Recovery Act
 4 Underground Storage Program2,000,000

5 Section 25. The following named amounts, or so much
 6 thereof as may be necessary, respectively, are appropriated
 7 for the ordinary and contingent expenses of the Office of the
 8 State Fire Marshal, as follows:

9 GRANTS

10 Payable from the Fire Prevention Fund:
 11 For Chicago Fire Department Training Program2,480,900
 12 For payment to local governmental agencies
 13 which participate in the State Training
 14 Programs950,000
 15 Total \$3,430,900

16 Section 30. The sum of \$1,000, or so much thereof as may
 17 be necessary, is appropriated from the Fire Prevention Fund
 18 to the Office of the State Fire Marshal for grants available
 19 for the development of new fire districts.

20 Section 35. The sum of \$125,000, or so much thereof as
 21 may be necessary, is appropriated from the Fire Prevention
 22 Fund to the Office of the State Fire Marshal for grants

1 available for costs and services related to ILEAS/MABAS
2 administration.

3 Section 40. The sum of \$8,000,000, or so much thereof as
4 may be necessary, is appropriated from the Fire Prevention
5 Fund to the Office of the State Fire Marshal for deposit into
6 the Fire Truck Revolving Loan Fund.

7 Section 45. The sum of \$1,000,000, or so much thereof as
8 may be necessary, is appropriated from the Fire Prevention
9 Fund to the Office of the State Fire Marshal for grants for
10 the Small Equipment Grant Program.

11 Section 50. The sum of \$550,000, or so much thereof as
12 may be necessary, is appropriated from the Underground
13 Storage Tank Fund to the Office of the State Fire Marshal for
14 a grant to the City of Chicago for administrative costs
15 incurred as a result of the State's Underground Storage
16 Program.

17 Section 99. Effective date. This Act takes effect July 1,
18 2014.
