## HOUSE RESOLUTION

2 WHEREAS, The members of the Illinois House of 3 Representatives wish to congratulate Garvin G. Ambrose on the 4 occasion of his appointment by Connecticut Governor Dannel P. 5 Malloy to the position of State Victim Advocate; and

6 WHEREAS, Garvin Ambrose was unanimously selected by the 7 Victim Advocate Advisory Committee and recommended to the 8 Governor of Connecticut to serve as the state's Victim 9 Advocate, charged with the responsibility of advising the 10 Connecticut General Assembly on system-wide improvements to 11 state services for victims of crime; Mr. Ambrose will continue to advocate for victims in court and work with private and 12 13 public agencies to enforce the constitutional rights of 14 victims; and

15 WHEREAS, Garvin Ambrose has recently served as the 16 Executive Assistant State's Attorney and Legislative Liaison 17 for the Cook County State's Attorney's Office; he has assisted 18 in the development of state-wide legislative and policy 19 initiatives that encompassed issues on civil, criminal, and 20 family law; and

Interest Bureau, Child Support Enforcement Division, where he
advocated on behalf of the Department of Healthcare and Family
Services by establishing and enforcing paternity; he was later
promoted into the Juvenile Justice Bureau, where he served in
the Child Protection Division and the Juvenile Delinquency
Division; and

7 WHEREAS, Garvin Ambrose's passion for helping and 8 influencing the lives of others extends into his work as an 9 assistant track and field coach at the University of Illinois 10 at Chicago; as a USATF Level 1 Certified Coach, he has led his 11 high jump athletes to many victories in state and national 12 competitions; he also mentors his athletes of the track, taking 13 them to cultural events, conversing with their professors about 14 grades, and helping them to steer through administrative 15 difficulties on campus; therefore, be it
