Amends the Department of Juvenile Justice Mortality Review Team Act. Provides that a mortality review team shall evaluate the role that life sentences without the opportunity for parole have in youth deaths.

AN ACT concerning criminal law.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Department of Juvenile Justice Mortality
Review Team Act is amended by changing Section 20 as follows:

Sec. 20. Reviews of youth deaths.

8 (a) A mortality review team shall review every death of a 9 youth that occurs within a facility of the Department or as the 10 result of an act or incident occurring within a facility of the 11 Department, including deaths resulting from suspected illness, 12 injury, or self-harm or from an unknown cause.

13 (b) If the coroner of the county in which a youth died 14 determines that the youth's death was the direct or proximate result of alleged or suspected criminal activity, the mortality 15 16 review team's investigation shall be in addition to any 17 criminal investigation of the death but shall be limited to a review of systems and practices of the Department. In the 18 19 course of conducting its review, the team shall obtain 20 assurance from law enforcement officials that acts taken in 21 furtherance of the review will not impair any criminal 22 investigation or prosecution.

(d) A mortality review team shall review a youth death as soon as practicable and not later than within 90 days after a law enforcement agency's completion of its investigation if the death is the result of alleged or suspected criminal activity. SB1343 - 3 - LRB098 06686 RLC 36732 b

1 If there has been no investigation by a law enforcement agency, 2 the mortality review team shall review a youth's death within 3 90 days after obtaining the information necessary to complete 4 the review from the coroner, pathologist, medical examiner, or 5 law enforcement agency, depending on the nature of the case. 6 The team shall meet as needed in person or via teleconference 7 or video conference following appointment of the team members. When necessary and upon request of the team, the Director may 8 9 extend the deadline for a review up to an additional 90 days.
