AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Vehicle Code is amended by changing 5 Sections 3-405 and 3-415 and by adding Section 3-918 as 6 follows:

8 Sec. 3-405. Application for registration.

9 (a) Every owner of a vehicle subject to registration under 10 this Code shall make application to the Secretary of State for 11 the registration of such vehicle upon the appropriate form or 12 forms furnished by the Secretary. Every such application shall 13 bear the signature of the owner written with pen and ink and 14 contain:

1. The name, domicile address, as defined in Section 15 16 1-115.5 of this Code, (except as otherwise provided in this 17 paragraph 1) and mail address of the owner or business address of the owner if a firm, association or corporation. 18 19 If the mailing address is a post office box number, the 20 address listed on the driver license record may be used to 21 verify residence. A police officer, a deputy sheriff, an 22 elected sheriff, a law enforcement officer for the Department of State Police, a fire investigator, a state's 23

1 assistant state's attorney, а attorney, an state's 2 attorney special investigator, or a judicial officer may 3 elect to furnish the address of the headquarters of the governmental entity, police district, or business address 4 5 where he or she works instead of his or her domicile address, in which case that address shall be deemed to be 6 7 his or her domicile address for all purposes under this 8 Chapter 3. The spouse and children of a person who may 9 elect under this paragraph 1 to furnish the address of the 10 headquarters of the government entity, police district, or 11 business address where the person works instead of the 12 person's domicile address may, if they reside with that furnish 13 person, also elect to the address of the 14 headquarters of the government entity, police district, or 15 business address where the person works as their domicile address, in which case that address shall be deemed to be 16 17 their domicile address for all purposes under this Chapter In this paragraph 1: (A) "police officer" has the 18 3. meaning ascribed to "policeman" in Section 10-3-1 of the 19 20 Illinois Municipal Code; (B) "deputy sheriff" means a deputy sheriff appointed under Section 3-6008 of the 21 22 Counties Code; (C) "elected sheriff" means a sheriff 23 commissioned pursuant to Section 3-6001 of the Counties 24 Code; (D) "fire investigator" means a person classified as 25 a peace officer under the Peace Officer Fire Investigation Act; (E) "state's attorney", "assistant state's attorney", 26

and "state's attorney special investigator" mean a state's attorney, assistant state's attorney, and state's attorney special investigator commissioned or appointed under Division 3-9 of the Counties Code; and (F) "judicial officer" has the meaning ascribed to it in Section 1-10 of the Judicial Privacy Act.

7 2. A description of the vehicle, including such
8 information as is required in an application for a
9 certificate of title, determined under such standard
10 rating as may be prescribed by the Secretary.

113. Information relating to the insurance policy for the12motor vehicle, including the name of the insurer which13issued the policy, the policy number, and the expiration14date of the policy. Beginning with the 2016 registration15year, registration shall not be issued to persons that16submit an application that does not contain this17information.

4. Such further information as may reasonably be
required by the Secretary to enable him to determine
whether the vehicle is lawfully entitled to registration
and the owner entitled to a certificate of title.

5. An affirmation by the applicant that all information set forth is true and correct. If the application is for the registration of a motor vehicle, the applicant also shall affirm that the motor vehicle is insured as required by this Code, that such insurance will be maintained SB1940 Enrolled - 4 - LRB098 10560 MLW 40805 b

throughout the period for which the motor vehicle shall be 1 registered, and that neither the owner, nor any person 2 3 operating the motor vehicle with the owner's permission, shall operate the motor vehicle unless the 4 required insurance is in effect. If the person signing 5 the 6 affirmation is not the sole owner of the vehicle, such 7 person shall be deemed to have affirmed on behalf of all 8 the owners of the vehicle. If the person signing the 9 affirmation is not an owner of the vehicle, such person 10 shall be deemed to have affirmed on behalf of the owner or 11 owners of the vehicle. The lack of signature on the 12 application shall not in any manner exempt the owner or owners from any provisions, requirements or penalties of 13 14 this Code. Beginning with the 2016 registration year, any 15 person that knowingly submits false insurance information 16 shall be quilty of a Class C misdemeanor.

(b) When such application refers to a new vehicle purchased from a dealer the application shall be accompanied by a Manufacturer's Statement of Origin from the dealer, and a statement showing any lien retained by the dealer.

(a) Calendar year. Application for renewal of a vehicle
registration shall be made by the owner, as to those vehicles

required to be registered on a calendar registration year, not 1 2 later than December 1 of each year, upon proper application and 3 by payment of the registration fee and tax for such vehicle, as provided by law except that application for renewal of a 4 5 vehicle registration, as to those vehicles required to be registered on a staggered calendar year basis, shall be made by 6 7 the owner in the form and manner prescribed by the Secretary of 8 State.

9 (b) Fiscal year. Application for renewal of a vehicle 10 registration shall be made by the owner, as to those vehicles 11 required to be registered on a fiscal registration year, not 12 later than June 1 of each year, upon proper application and by payment of the registration fee and tax for such vehicle as 13 14 provided by law, except that application for renewal of a 15 vehicle registration, as to those vehicles required to be 16 registered on a staggered fiscal year basis, shall be made by 17 the owner in the form and manner prescribed by the Secretary of 18 State.

19 Two calendar years. Application for renewal of a (C) 20 vehicle registration shall be made by the owner, as to those vehicles required to be registered for 2 calendar years, not 21 22 later than December 1 of the year preceding commencement of the 23 2-year registration period, except that application for renewal of a vehicle registration, as to those vehicles 24 required to be registered for 2 years on a staggered 25 26 registration basis, shall be made by the owner in the form and

1 manner prescribed by the Secretary of State.

2 (d) Two fiscal years. Application for renewal of a vehicle 3 registration shall be made by the owner, as to those vehicles required to be registered for 2 fiscal years, not later than 4 5 June 1 immediately preceding commencement of the 2-year registration period, except that application for renewal of a 6 7 vehicle registration, as to those vehicles required to be registered for 2 fiscal years on a staggered registration 8 9 basis, shall be made by the owner in the form and manner 10 prescribed by the Secretary of State.

(d-5) Three calendar years. Application for renewal of a vehicle registration shall be made by the owner, as to those vehicles required to be registered for 3 calendar years, not later than December 1 of the year preceding commencement of the 3-year registration period.

(e) Time of application. The Secretary of State may receive
applications for renewal of registration and grant the same and
issue new registration cards and plates or registration
stickers at any time prior to expiration of registration. No
person shall display upon a vehicle, the new registration
plates or registration stickers prior to the dates the
Secretary of State in his discretion may select.

(f) Verification. The Secretary of State may further require, as to vehicles for-hire, that applications be accompanied by verification that fees due under the Illinois Motor Carrier of Property Law, as amended, have been paid. SB1940 Enrolled - 7 - LRB098 10560 MLW 40805 b

1	(g) Applications for registration renewal shall include
2	information relating to the insurance policy for the motor
3	vehicle, including the name of the insurer that issued the
4	policy, the policy number, and the expiration date of the
5	policy. Registration shall not be renewed for persons that
6	submit an application that does not contain this information.
7	Any person that knowingly submits false insurance information
8	shall be quilty of a Class C misdemeanor.

9 <u>The changes to this subsection made by this amendatory Act</u> 10 <u>of the 98th General Assembly shall not take effect until the</u> 11 <u>beginning of the 2016 registration year.</u>

(625 ILCS 5/3-918 new)

Sec. 3-918. Vehicle registration and insurance. Beginning 14 15 with the 2016 registration year, any remittance agent engaged 16 in the business of remitting applications for the issuance or renewal of vehicle registration shall ask applicants for 17 18 information relating to the insurance policy for the motor vehicle, including the name of the insurer that issued the 19 policy, the policy number, and the expiration date of the 20 21 policy. This information shall be remitted to the Secretary of 22 State as part of the application. Failure to obtain this 23 information and supply it to the Secretary of State shall subject the remittance agent to suspension or revocation of 24 25 their license as described in Section 3-907 of this Code.
