

98TH GENERAL ASSEMBLY State of Illinois 2013 and 2014 SB2665

SYNOPSIS AS INTRODUCED:

625 ILCS 45/5-14

from Ch. 95 1/2, par. 315-9

Amends the Boat Registration and Safety Act. Requires operators of a watercraft towing a person or persons to display purple flags on their watercraft. Requires this flag to be displayed at the highest point of the boat's helm. Effective January 1, 2015.

1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Boat Registration and Safety Act is amended by changing Section 5-14 as follows:
- 6 (625 ILCS 45/5-14) (from Ch. 95 1/2, par. 315-9)
- 7 Sec. 5-14. <u>Towing of Persons</u>. Water Skiing.
- A. No person may operate a motorboat that has in tow or is otherwise assisting a person on water skis, an aquaplane, or a similar contrivance in or upon any waterway, unless the motorboat has a capacity of at least 3 persons and is occupied by at least 2 competent persons.
- B. No person may operate a motorboat having in tow or otherwise be assisting a person on water skis, aquaplane or similar contrivance from the period of one-half hour after sunset to one-half hour before sunrise. This paragraph B does not apply to motorboats used in duly authorized water ski tournaments, competitions, exhibitions or trials therefor where adequate lighting is provided.
- 20 C. All persons operating a motorboat having in tow or 21 otherwise assisting a person on water skis, aquaplane or 22 similar contrivance, must be careful and prudent in their 23 operation and keep at a reasonable distance from persons and

- property so as not to endanger the life or property of any person.
- D. No person may operate or manipulate any vessel, tow rope or other device by which the direction or location of water skis, aquaplane, or similar device may be affected or controlled in such a way as to cause the water skis, aquaplane, or similar device, or any persons thereon to collide with or strike against any person or object, except ski jumps, buoys and like objects normally used in competitive or recreational
- 11 E. The operator of any watercraft that is towing a person 12 or persons shall display on the watercraft a bright or 13 brilliant purple flag measuring not less than 12 inches per 14 side. The flag shall be displayed at the highest point of the area surrounding the boat's helm as to be visible from all 15 directions, continuously, while the person or persons being 16 17 towed depart the boat in preparation for towing and until reentry into the boat when the activity has ceased. Display of 18 19 the flag for purposes other than the activity described in this 20 Section is prohibited.

- 22 Section 99. Effective date. This Act takes effect January 23 1, 2015.
