National Guard. For purposes of this Section, residence is that 1 abode which the applicant considers his or her home. Applicants may provide as sufficient proof of such residence and as an acceptable form of identification a driver's license, valid passport, military ID, or other form of government-issued national or foreign identification that shows the applicant's name, address, date of birth, signature, and photograph or 7 other acceptable identification as may be allowed by law or as regulated by the Illinois Community College Board. Such regional superintendent shall determine if the applicant meets statutory and regulatory state standards. Any applicant who has achieved the minimum passing standards as established by the Illinois Community College shall be notified in writing by the regional superintendent and shall be issued a high school equivalency certificate on the forms provided by the Illinois Community College Board. The regional superintendent shall then certify to the Illinois Community College Board the score of the applicant and such other and additional information that may be required by the Illinois Community College Board. The moneys received therefrom shall be used in the same manner as provided for in this Section.

Education administered for the Illinois State Penitentiary System and the Department of Corrections. Such applicant shall apply to the regional superintendent of the region wherein he has maintained residence, and upon payment of a fee established Illinois Community College Board the superintendent shall issue а high school equivalency certificate, and immediately thereafter certify to Illinois Community College Board the score of the applicant and such other and additional information as may be required by the Illinois Community College Board.

quality education from preschool through graduate school. This State needs a framework to guide education policy and integrate education at every level. A statewide coordinating council to study and make recommendations concerning education at all levels can avoid fragmentation of policies, promote improved learning, and continue to cultivate and demonstrate strong accountability and efficiency. Establishing an Illinois P-20 Council will develop a statewide agenda that will move the State towards the common goals of improving academic achievement, increasing college access and success, improving use of existing data and measurements, developing improved accountability, fostering innovative approaches to education, promoting lifelong learning, easing the transition to college, and reducing remediation. A pre-kindergarten through grade 20 agenda will strengthen this State's economic competitiveness by producing a highly-skilled workforce. In addition, lifelong learning plans will enhance this State's ability to leverage funding.

- There is created the Illinois P-20 Council. 19 Illinois P-20 Council shall include all of the following 20 members: 21
- 22 (1) The Governor or his or her designee, to serve as 23 chairperson.
 - (2) Four members of the General Assembly, one appointed by the Speaker of the House of Representatives, appointed by the Minority Leader of the House

Representatives, one appointed by the President of the Senate, and one appointed by the Minority Leader of the Senate.

- (3) Six at-large members appointed by the Governor as follows, with 2 members being from the City of Chicago, 2 members being from Lake County, McHenry County, Kane County, DuPage County, Will County, or that part of Cook County outside of the City of Chicago, and 2 members being from the remainder of the State:
 - (A) one representative of civic leaders;
 - (B) one representative of local government;
 - (C) one representative of trade unions;
- (D) one representative of nonprofit organizations or foundations;
 - (E) one representative of parents' organizations; and
 - (F) one education research expert.
 - Five members appointed by statewide business (4) organizations and business trade associations.
 - (5) Six members appointed by statewide professional organizations and associations representing pre-kindergarten through grade 20 teachers, community college faculty, and public university faculty.
 - (6) Two members appointed by associations representing local school administrators and school board members. One of these members must be a special education administrator.

- 3 (I) The president of an association representing educators of adult learners or his or her designee.
- 5 Ex-officio members shall have no vote on the Illinois P-20 Council.

Appointed members shall serve for staggered terms expiring on July 1 of the first, second, or third calendar year following their appointments or until their successors are appointed and have qualified. Staggered terms shall be determined by lot at the organizing meeting of the Illinois P-20 Council.

Vacancies shall be filled in the same manner as original appointments, and any member so appointed shall serve during the remainder of the term for which the vacancy occurred.

- (c) The Illinois P-20 Council shall be funded through State appropriations to support staff activities, research, data-collection, and dissemination. The Illinois P-20 Council shall be staffed by the Office of the Governor, in coordination with relevant State agencies, boards, and commissions. The Illinois Education Research Council shall provide research and coordinate research collection activities for the Illinois P-20 Council.
- 24 (d) The Illinois P-20 Council shall have all of the following duties:
 - (1) To make recommendations to do all of the following:

(A) Coordinate pre-kindergarten through grade 20 1 2 (graduate school) education in this State through 3 working at the intersections of educational systems to promote collaborative infrastructure. (B) Coordinate and leverage strategies, actions, 6 legislation, policies, and resources all 7 stakeholders to support fundamental and lasting 8 improvement in this State's public schools, community 9 colleges, and universities. 10 (C) Better align the high school curriculum with 11 postsecondary expectations. 12 (D) Better align assessments across all levels of 13 education. for 14 (E) Reduce the need students entering 15 institutions of higher education to take remedial 16 courses. 17 (F) Smooth the transition from high school to 18 college. 19 Improve high school and college graduation 20 rates. 21 (H) Improve the rigor and relevance of academic 22 standards for college and workforce readiness. 23 (I) Better align college and university teaching

- (e) The chairperson of the Illinois P-20 Council may authorize the creation of working groups focusing on areas of interest to Illinois educational and workforce development, including without limitation the following areas:
 - (1) Preparation, recruitment, and certification of highly qualified teachers.
 - (2) Mentoring and induction of highly qualified teachers.
 - (3) The diversity of highly qualified teachers.
 - (4) Funding for highly qualified teachers, including developing a strategic and collaborative plan to seek federal and private grants to support initiatives targeting teacher preparation and its impact on student achievement.
- (5) Highly effective administrators.
- 25 (6) Illinois birth through age 3 education, 26 pre-kindergarten, and early childhood education.

- 1 (7) The assessment, alignment, outreach, and network of college and workforce readiness efforts.
 - (8) Alternative routes to college access.
 - (9) Research data and accountability.
- 5 (10) Community schools, community participation, and 6 other innovative approaches to education that foster 7 community partnerships.

The chairperson of the Illinois P-20 Council may designate

Council members to serve as working group chairpersons. Working

groups may invite organizations and individuals representing

(2) if anticipating State revenues expected to be due in the next subsequent fiscal year, 50% of the amount or amounts of the revenues due in the current fiscal year, as certified by the Executive Director President/CEO of the State Board or other official in a position to provide assurances as to the amounts.

All moneys so borrowed shall be repaid exclusively from the anticipated revenues within 60 days after the revenues have been received. Borrowing authorized under subdivisions (1) and (2) of this Section shall bear interest at a rate not to exceed the maximum rate authorized by the Bond Authorization Act, from the date of issuance until paid.

Prior to establishing a line of credit under this Section, the board shall authorize, by resolution, the line of credit. The resolution shall set forth facts demonstrating the need for the line of credit, state the amount to be borrowed, establish a maximum interest rate limit not to exceed that set forth in this Section, and provide a date by which the borrowed funds must be repaid. The resolution shall direct the relevant officials to make arrangements to set apart and hold the revenue, as received, that will be used to repay the borrowing. addition, the resolution may authorize the relevant officials to make partial repayments of the borrowing as the revenues become available and may contain any other terms, restrictions, or limitations not inconsistent with the

- provisions of this Section. 1
