- Sec. 17. Penalties. 2
- (a) Any person convicted of any act of abuse or neglect or 3
- of violating any other provision of this Act, except Section 19 5 of this Act, for which a penalty is not otherwise provided, or
- any rule, regulation, or order of the Department pursuant 6
- thereto, is guilty of a Class B misdemeanor. A second or 7
- 8 subsequent violation is a Class 4 felony with every day that a
- 9 violation continues constituting a separate offense.

- 19 Code of 2012, by a defendant 18 years of age or older, the
- 20 presiding judge shall notify the defendant that the conviction
- 21 will be reported to the national Do Not Adopt Registry. The
- court shall order the clerk of the court to send notice of the 22
- 23 conviction and the defendant's name, date of birth, and offense
